## **COLLEGE PARK MAN SENTENCED TO OVER TWO YEARS IN PRISON FOR INCOME TAX EVASION, IMMEDIATELY TAKEN INTO CUSTODY**

### *Braddy Under-reported His Income by More than \$1.1 Million in Tax Years 2003-05*

ATLANTA, GA - ROBERT L. BRADDY, JR., 39, of College Park, Georgia, was sentenced today by United States District Judge William S. Duffey, Jr. to serve over 2 years in federal prison for income tax evasion. BRADDY was immediately remanded to the custody of the United States Marshals Service at the conclusion of the sentencing hearing.

United States Attorney Sally Quillian Yates said of the case, "This defendant hid over one million dollars in income and cheated his fellow citizens who pay their fair share of taxes. Now he is going to prison."

IRS-Criminal Investigation Special Agent in Charge Reginael McDaniel said, "IRS investigators continue to work tirelessly to make sure tax cheaters do not win. In this case, this defendant immediately went into custody after sentencing, and he has already begun a federal prison sentence with no parole."

BRADDY was sentenced to serve 2 years, 6 months in prison, followed by 3 years of supervised release, and ordered to pay \$306,906 in restitution. BRADDY pleaded guilty to the charge on February 24, 2010.

According to United States Attorney Yates, the indictment, and other information presented in court: When BRADDY filed his 2003, 2004 and 2005 federal income tax returns, he willfully attempted to evade a large part of the income tax he owed the United States by filing a false and fraudulent U.S. Individual Income Tax Return (Form 1040). For each of the returns he filed, he knew that his total income and the tax due and owing substantially exceeded the amounts that he reported. BRADDY under-reported his income by more than \$1.1 million and under-paid his income taxes by \$306,906.

This case was investigated by Special Agents of the Internal Revenue Service-Criminal Investigation.

Assistant United States Attorney Russell Phillips prosecuted the case.
