I HAVE BEEN A SPECIAL AGENT 12 (SA) FOR APPROXIMATELY 2 YEARS, AND CURRENTLY AM ASSIGNED TO THE 13 ALBUQUERQUE DIVISION OF THE FBI. THE FOLLOWING FACTS WERE DETERMINED DURING THE COURSE OF AN INVESTIGATION CONDUCTED BY 14 AGENTS OF THE FBI AND NAVAJO POLICE DEPARTMENT CRIMINAL 15 INVESTIGATORS. 16 17 2) AT APPROXIMATELY 4:30 PM ON 09/23/2010 SHIPROCK CRIMINAL INVESTIGATOR JEFF JOE CONTACTED SA DUSTIN GRANT REGARDING 18 AN ATTEMPTED MURDER CASE. CI JOE RELATED THE FOLLOWING: 19 20 3) AT APPROXIMATELY 3:30 PM ON 09/23/2010, THE SHIPROCK POLICE DEPARTMENT WAS CONTACTED BY THE NORTHERN NAVAJO MEDICAL 21 CENTER (NNMC) FOR THE REPORT OF A FEMALE, LATER IDENTIFIED AS 22 CHERLYNCIA YAZZIE, WHO HAD SUFFERED INJURIES TO THE THROAT. THE 23 INJURIES WERE DESCRIBED AS A DEEP LACERATION THAT WENT THROUGH HER TRACHEA, WINDPIPE, VOICE BOX, NECK MUSCLES, AND CLOSE TO THE SPINAL 24 CORD. LACERATIONS WERE ALSO FOUND ON YAZZIE'S LEFT EYE AND LEFT 25 HAND. SHIPROCK POLICE DEPARTMENT OFFICERS RESPONDED TO NNMC, WHERE 26 THEY CONTACTED AND IDENTIFIED THE HUSBAND OF YAZZIE, MICHAEL HARRISON. HARRISON HAD DRIVEN YAZZIE TO THE HOSPITAL. HARRISON WAS 27 ARRESTED AND TRANSPORTED TO THE SHIPROCK DETENTION CENTER. DURING

TREATMENT FOR YAZZIE'S INJURIES THE NURSE ASSISTING YAZZIE ASKED

HER WHO WAS RESPONSIBLE FOR THE INJURY. YAZZIE REPLIED THAT IS WAS THE PERSON THAT HAD JUST LEFT, INDICATING TO MICHAEL HARRISON WHO HAD BROUGHT HER TO NNMC.

- 4) WHILE BEING BOOKED AT THE DETENTION CENTER HARRISON MADE A SPONTANEOUS STATEMENT TO THE DETENTION OFFICER TO THE EFFECT OF "I FUCKED UP. I'M GOING TO PRISON. I STABBED MY GIRLFRIEND TWICE TO THE THROAT."
- 5) AT APPROXIMATELY 5:30 PM AN OFFICER OF THE SHIPROCK POLICE DEPARTMENT RESPONDED TO THE RESIDENCE LOCATED AT SOUTH NON-PROFIT HOUSING, #05, SHIPROCK, NEW MEXICO. A CHECK OF REGISTERED OWNERS IDENTIFIED CHERLYNCIA YAZZIE BEING REGISTERED TO THE RESIDENCE. THE OFFICER RESPONDING WENT INSIDE THE RESIDENCE TO DETERMINE IF ANYONE ELSE WAS INJURED AND DO A WELFARE CHECK ON ANY CHILDREN PRESENT. WHILE IN THE RESIDENCE, THE OFFICER NOTICED APPARENT BLOOD IN THE LIVING ROOM AREA AND A KITCHEN KNIFE ON THE LIVING ROOM COUCH WITH APPARENT BLOOD ON IT. APPARENT BLOOD WAS ALSO FOUND OUTSIDE OF THE RESIDENCE NEAR THE BACK DOOR. THE OFFICER LEFT THE RESIDENCE AND SECURED THAT LOCATION.
- 6) CI JOE ALSO DESCRIBED APPARENT BLOOD ON HARRISON'S HANDS AND HIS CLOTHING.
- 7) A SEARCH WARRANT WAS CONDUCTED ON 09/23/2010 OF THE RESIDENCE OF CHERLYNCIA YAZZIE LOCATED AT SOUTH NON-PROFIT HOUSING, #05, SHIPROCK, NEW MEXICO. DURING THE SEARCH, A LARGE KITCHEN KNIFE WAS FOUND IN THE FRONT LIVING ROOM COUCH, WHICH HAD APPARENT BLOOD STAINS ON THE BLADE.
- 8) A CHECK OF NAVAJO NATION ENROLLMENT RECORDS, SHOW BOTH YAZZIE AND HARRISON ARE ENROLLED MEMBERS OF THE NAVAJO INDIAN TRIBE.
- 9) BASED ON THE ABOVE, YOUR AFFIANT BELIEVES, YOUR AFFIANT BELIEVES PROBABLE CAUSE EXISTS TO BELIEVE MICHAEL HARRISON, AN INDIAN PERSON, COMMITTED THE FOLLOWING OFFENSES: ATTEMPTED
