The defendant and both victims are enrolled in the Navajo Indian Census Roll and the crime was committed within the confines of the Navajo Indian Reservation.

I am a Special Agent with the United States Department of Justice, Federal Bureau of Investigation 11 (FBI) and have been employed as such since 1999. I am 12 currently assigned to the Albuquergue Division of the FBI, 13 Farmington Resident Agency, and have primary investigative 14 responsibility in crimes that occur in Indian Country, 15 including violent crimes such as homicide, robbery, arson, 16 aggravated assault, and sexual assault. The information 17 set forth in this affidavit has been derived from an 18 investigation conducted by affiant, Criminal Investigator 19 Marc Scott of the Navajo Nation Department of Public 20 Safety, FBI Task Force Officer Carl Sexton, and/or 21 communicated to me by other law enforcement officers. 22 23 2. On or around February 14, 2010, Chebon Joe 24 Wilson (hereinafter referenced as Chebon) engaged in sexual 25 acts with Jane Doe 1 (Age 6) and Jane Doe 2 (Age 8) by 26 using his hand/finger to penetrate their genital opening. 27 The defendant and both victims are enrolled in the Navajo 28

Indian Census Roll and the crimes set forth below were committed within the confines of the Navajo Indian Reservation.

3. On February 18, 2010, at approximately 1936 5 hours, Vera Jackson, the grandmother of Jane Doe 1 (Birth 6 7 Year 2003) and Jane Doe 2 (Birth Year 2001), contacted the Shiprock Police Department to report a child molesting of 8 her aforementioned granddaughters by their stepfather, 9 Chebon Wilson (Birth Year 1983). Shortly thereafter, 10 Officer Anderson Dez with the Shiprock Police Department 11 responded to the residence 1/4 mile east of the 7-11 Store 12 in Shiprock, New Mexico. Upon his arrival, Officer Dez met 13 with Cheryl Wilson, the mother of Jane Doe 1 and Jane Doe 14 2. Cheryl Wilson reported that Chebon was touching the 15 private parts of her two daughters, Jane Doe 1 and Jane Doe 16 Cheryl Wilson learned about the above allegations from 17 2. Vera Jackson, who received a note from Jane Doe 1 that 18 said, "I hate Chebon, he digs in my private." 19

4. On February 18, 2010, at approximately 2210 21 22 hours, Cheryl Wilson took her daughters, Jane Doe 1 and Jane Doe 2, to the Emergency Room at the Northern Navajo 23 Medical Center (NNMC). At approximately 0145 hours 24 (February 19, 2010), Dr. Sandra Beirne with NNMC Pediatrics 25 interviewed Jane Doe 1 and Jane Doe 2 based on the 26 allegations of sexual assault by their stepfather, Chebon. 27 Jane Doe 1 told Dr. Beirne that Chebon touched her privates 28

with his hand when they were laying on the bed in her "mommy's bedroom." Jane Doe 1 reported that it happened on Sunday (February 14, 2010), and that it also happened on ten other occasions. Jane Doe 1 stated that it happened 4 the first time when she was five years of age. She also stated that it hurt when Chebon touched her privates. Jane 6 Doe 2 told Dr. Beirne that on or around February 16, 2010, Chebon touched her privates with his hand while they were laying together on her baby sister's bed watching 9 10 television. Jane Doe 2 said that Chebon Wilson has not touched her privates before or since then. Jane Doe 2 also 11 reported that she was scared of Chebon. 12

5. On February 19, 2010, the Sexual Assault 14 Services of NW New Mexico (SANE) located in Farmington, New 15 Mexico, conducted sexual assault examinations on both Jane 16 Doe 1 and Jane Doe 2. Kathy Barrett, SANE Coordinator, 17 advised affiant that the preliminary results of the sexual 18 assault examinations for both girls were negative and did 19 not reflect any injuries to the girls, however, the 20 official report which is reviewed by a medical doctor, is 21 forthcoming and will be released to affiant at a later 22 date. 23

On February 26, 2010, Letitia Lee with Child 6. 25 Haven in Farmington, New Mexico, conducted a forensic 26 interview with Jane Doe 1 at Child Haven in reference to 27 the allegations that her stepfather, Chebon Wilson, 28

sexually assaulted her. Jane Doe 1 provided detailed 1 information about how Chebon touched and penetrated her 2 vagina with his finger. Jane Doe 1 stated that this 3 occurred on multiple occasions (Affiant's recollection 4 since the forensic interview was that Jane Doe 1 stated it 5 occurred approximately eight different times) in her 6 7 mother's bedroom while watching television. Jane Doe 1 stated that Chebon would lie next to her on the bed and 8 would put his hand down her pants and touch her privates in 9 the front but not the back. Jane Doe 1 said that her 10 clothes were always on and so were Chebon's clothes. Jane 11 Doe 1 also said that Chebon never touched her privates with 12 anything other than his hand/finger. Jane Doe 1 said that 13 when Chebon would put his finger in her privates it hurt. 14 Jane Doe 1 also drew pictures and marked on several pieces 15 of paper what happened and where Chebon touched her. 16

7. On February 26, 2010, Letitia Lee with Child 18 Haven in Farmington, New Mexico, conducted a forensic 19 interview with Jane Doe 2 at Child Haven in reference to 20 the allegations that her stepfather, Chebon Wilson, 21 sexually assaulted her. Jane Doe 2 seemed more reluctant 22 to talk than her sister. Jane Doe 2 stated that Chebon 23 only touched her privates in the front on one occasion 24 25 while they were watching television together in her mother's room. Jane Doe 2 said nothing else happened and 26 that their clothes were on during the incident. It is 27 affiant's recollection that Jane Doe 2 did not disclose 28

that Chebon penetrated her privates with his finger or any other object, but that he did put his hand down her pants and touched her vagina. Jane Doe 2 also marked on a piece of paper where Chebon touched her.

8. Between the time period of February 22, 2010,
when the above-referenced information was first reported to
the FBI, and March 23, 2010, affiant attempted to locate
Chebon to interview him, but was unsuccessful in finding
him.

9. On March 24, 2010, at approximately 0830
hours, affiant learned from FBI Task Force Officer Carl
Sexton that Chebon Wilson was in custody and currently at
the Magistrate Court in Farmington, New Mexico, on
unrelated charges.

10. On March 24, 2010, at approximately 1030 18 19 hours, affiant and FBI Task Force Officer Carl Sexton interviewed Chebon Wilson in a room at the Farmington 20 Magistrate Court regarding the above-referenced sexual 21 assault allegations. Chebon was read his Miranda Rights 22 and then signed an FBI Advice of Rights form giving consent 23 to answer questions and talk to the interviewing 24 agents/officers without an attorney present. 25

27 11. In summary, Chebon Wilson told the agents he 28 received some drugs/pills (eight or nine) in a prescription

bottle from a stranger on the street in Farmington sometime 1 in February 2010. Chebon wanted the drugs/pills because he 2 was having headaches. Chebon had not been to his residence 3 in Shiprock where Cheryl Wilson, his wife, and daughters 4 were living for several days. Two or three days after 5 taking the drugs/pills, Chebon went to his residence and 6 that is when he touched Jane Doe 1 and Jane Doe 2's 7 8 privates. Chebon confessed to putting his hand down Jane Doe 1's pants while she and Chebon were on his bed watching 9 television. He also confessed to doing it on four or five 10 separate occasions. Chebon said he assumed he penetrated 11 Jane Doe 1's vagina with his finger but was not positive 12 13 because of the drugs/pills he had taken. Chebon said he did not realize what he was doing to Jane Doe 1 each time 14 until he "snapped" from the drugs, and then he would take 15 his hand out of Jane Doe 1's pants. Chebon used the term 16 "snapped" throughout the interview to mean that he came to 17 and realized what he was doing. Throughout the interview 18 19 Chebon blamed the drugs/pills he had taken for what he did sexually with Jane Doe 1 and Jane Doe 2. 20

12. Chebon confessed to touching Jane Doe 2's privates on one or two occasions while watching television in his bedroom on the bed. Chebon confessed to doing the same thing with Jane Doe 2 as he had with Jane Doe 1. Chebon denied having intercourse with Jane Doe 1 and Jane Doe 2, and also denied touching them anywhere other than in their vagina area. Chebon said he and his stepdaughters

were always fully clothed when he touched their private areas. Based upon the information provided in this 13. affidavit your affiant believes there is probable cause to believe that Chebon Wilson violated Title 18 United States Code, Sections 1153, 2241(c), and 2246(2)(C).
