SELECTED FUNDING OPPORTUNITIES

Note: Grant solicitations are posted throughout the year and, in most cases, remain open for several weeks.

Selected Formula Grants:

Byrne Justice Assistance Grants

The Edward Byrne Memorial Justice Assistance Grant (JAG) program is the primary provider of federal criminal justice funding to state and local jurisdictions. This formula grant program provides states and units of local governments with critical funding necessary to support a range of program areas including law enforcement, prosecution and court programs, corrections and community corrections, drug treatment and enforcement, crime victim and witness initiatives, planning, evaluation, and technology improvement programs. The solicitation identifies support for indigent defense as one of several key priority areas for maximizing the effectiveness of JAG funding at the state and local level. State and local jurisdictions are encouraged to bring all system stakeholders together in a strategic criminal justice planning process to guide JAG funding, and the Department notes that "our recommended guidelines are that at a minimum, the strategic planning process includes law enforcement, courts, prosecutors, indigent defense providers, victim advocates, and corrections officials." This year's solicitation also incorporates new application requirements to help the Department "assess[] the extent to which states are engaged in strategic planning in making allocation decisions about JAG funds, and the extent to which the recommendation that these efforts include all criminal justice stakeholders, including indigent defense, are being followed to ensure fairness in the criminal justice system."

Juvenile Accountability Incentive Block Grants

The Juvenile Accountability Block Grants (JABG) program supports states and units of local government in their efforts to strengthen juvenile justice systems. The program's goal is to help communities implement accountability-based programs that focus on both offenders and the juvenile justice system while supporting both state and local efforts in those same areas. Some of the 17 "JABG purpose areas" include hiring juvenile court judges, court-appointed defenders and special advocates, among others, and funding pretrial services (including mental health screening and assessment) for juvenile offenders; establishing and maintaining restorative justice programs; and establishing, improving, and coordinating pre-release and post-release systems and programs to facilitate the successful re-entry of juvenile offenders from state and local custody in the community.

Juvenile Title II Formula Grant Program

The Juvenile Title II Formula Grant Program supports state and local efforts to plan, establish, operate, coordinate, and evaluate projects directly or through grants and contracts with public and private agencies for the development of more effective education, training, research, prevention, diversion, treatment, and rehabilitation programs in the area of juvenile delinquency and programs to improve the juvenile

justice system. The program's goal is to increase the availability and types of prevention and intervention programs and juvenile justice system improvements. Program areas include Youth or Teen Courts, Court Services, and Indigent Defense.

Selected Discretionary Grants:

Adult Drug Court Discretionary Grant

The Bureau of Justice Assistance distributed grants to establish new drug courts or enhance existing drug court services, coordination, and offender management and recovery support services in FY2012. Solicitations for this grant program have been issued since 2002.

Capital Case Litigation Initiative

The Bureau of Justice Assistance distributes grants to state agencies in states that authorize capital punishment and that conduct, or will conduct prosecutions in which capital punishment is sought to improve the quality of representation and the reliability of verdicts in state and local capital cases through training for state and local prosecutors, defense counsel and trial judges. Solicitations for this grant program have been issued since 2006.

John R. Justice Student Loan Repayment Program

Under this program, the Bureau of Justice Affairs provides loan repayment assistance for state and federal public defenders and state prosecutors who agree to remain employed as public defenders and prosecutors for at least three years. Solicitations for this funding have been offered since 2010.

Office of Violence Against Women Court Training and Improvement

This program funds projects that improve internal civil and criminal court functions, responses, practices, and procedures and provide education for court-based and -related personnel on issues relating to victims' needs, including safety, security, privacy, confidentiality, and economic independence, as well as information about perpetrator behavior and best practices for holding perpetrators accountable. Solicitations for this grant have been offered since 2007.

PJI/BJA Prosecutor and Defense Attorney Fellows Program

In an effort to engage the prosecution and defense communities in the implementation of safe, fair and effective pretrial justice practices, the Bureau of Justice Assistance is sponsoring a Visiting Fellows program with the Pretrial Justice Institute ("PJI"). The program will support one public defender (or defense counsel who serves primarily indigent clients) and one prosecutor to function as subject matter experts with PJI on a part-time basis for one year. Each fellow will assist PJI in a variety of activities in order to reach the broadest possible audience of defenders and prosecutors, while focusing on the specific concerns and needs of each community regarding pretrial justice.

Targeted to non-profit organizations, including tribal enterprises and educational institutions, these grants serve to strengthen and improve the representation of indigent defendants in criminal cases and indigent respondents in civil causes of action under the jurisdiction of Indian tribes. Tribal Court Trial Advocacy Program

The Bureau of Indian Affairs' (BIA) Office of Tribal Justice Systems with DOJ's Access to Justice Initiative is organizing a series of free trial advocacy courses designed specifically for tribal courts. The Tribal Court Trial Advocacy Training Program is designed to enhance the trial advocacy skills for tribal court defenders, tribal court prosecutors, and tribal court judges. The program endeavors to strengthen tribal courts in furtherance of the Tribal Law and Order Act of 2010 (TLOA) by enhancing the skills of those who appear in tribal courts so that tribes can exercise greater sovereignty in criminal justice matters that occur on their lands. All trainings are free and open to judges, public defenders, and prosecutors who appear in tribal courts.
