Re: Title VI Compliance Review – February 16-19, 2010

Dear Mr. Morioka:

The Hawaii Department of Transportation (HDOT) is the recipient of one or more federal transit grants, loans and/or contracts awarded by the U.S. Department of Transportation, Federal Transit Administration (FTA). The FTA Office of Civil Rights (TCR) has been delegated the responsibility by the Secretary of Transportation to conduct periodic on-site compliance reviews of recipients of such grants, loans or contracts.

In this connection, TCR has engaged the services of the DMP Group (DMP) to assist with the Compliance Review of HDOT's Title VI Program pursuant to Title VI of the Civil Rights Act of 1964, as amended, the Department of Transportation implementing regulations, 49 CFR Part 21, and Circular 4702.1A, "Title VI and Title VI-Dependent Guidelines for Federal Transit Administration Recipients." The purpose of the Review is to determine the extent to which U.S. Department of Transportation Title VI requirements are being met. As was agreed by Derrin Jourdan, FTA Region IX Civil Rights Officer and Tammy Lee of your staff, the on-site Review will be held on Tuesday, February 16, 2010 through Friday, February 19, 2010. The dates of the Review were selected to provide HDOT adequate time to gather materials needed for the Review and to arrange for the availability of staff during the on-site Review.

An Entrance Conference will be held at 10:00 a.m. on Tuesday to discuss the on-site schedule and review the materials requested in this letter. On Friday, February 19, 2010 at 10:00 a.m., the Review team will identify additional data needs and present preliminary findings at an Exit Conference. You and your staff will be given an opportunity to ask questions and/or comment on these preliminary findings. A written report of findings and recommendations will be prepared and sent to you at a later date.

The Review team will focus on the Title VI compliance areas that are contained in FTA Circular 4702.1A that became effective on May 13, 2007. These compliance areas are contained in the Circular's Chapter IV (General Requirements and Guidelines), and Chapter VI (Program-Specific Requirements and Guidelines for State Departments of Transportation or Other Administrating Agencies). The general requirements and guidelines now include implementation of the Environmental Justice (EJ) and Limited English Proficiency (LEP) Executive Orders as well as the DOT's Title VI regulations at 49 CFR §21. We will interview employees who have responsibilities related to implementation of these directives and representatives of local minority and low-income community organizations and conduct subrecipient field visits to observe transit services and related benefits to minority, non-minority and low-income riders. The Compliance Review will not apply the new circular's provisions to actions that were taken by HDOT prior to the Circular's effective date. Rather, we will seek to determine the extent to which your current practices are consistent with this circular's provisions. Chapter VIII of Circular 4702.1A contains additional details of FTA's Title VI compliance review process.

So that our staff and contractors may properly prepare for the site visit, it is important that we receive copies of the information listed on the enclosed document by Wednesday, January 27, 2010. The following DMP personnel will conduct the Compliance Review: John Potts, Khalique Davis, and Bridgett Gagne. These persons are authorized to have access to documents, individuals and other information, at all reasonable times, in the conduct of the Compliance Review. They are also authorized to examine records, copy materials and record the statements of such persons as are reasonably necessary for completion of the Review.

We recommend that your staff review the Title VI information that is available at the FTA Office of Civil Rights' website, http://www.fta.dot.gov/civilrights/civil_rights_5088.html. The Title VI web page includes links to the final reports of Title VI compliance reviews conducted of other FTA grantees and to technical assistance documents such as FTA's handbook on implementing the DOT LEP Guidance and a link to the FTA/FHWA environmental justice web page. These resources may help HDOT prepare for the upcoming Review and/or respond to any findings of deficiencies or advisory comments issued after the Review.

We are obligated to inform you that under the Freedom of Information Act, it may be necessary to release this document and related correspondence and records upon request. Should we receive such a request, we will seek to protect, to the extent provided by law, personal information, which, if released, could constitute an unwarranted invasion of privacy.

Your cooperation and assistance in preparing for the Review is greatly appreciated. 0. Background

- b) List of all HDOT subrecipients by FTA program area, e.g., FTA Section 5309, 5310, 5311, 5316, and 5317 subrecipients.
- c) A map or chart of the distribution of FTA Section 5309, 5310, 5311, 5316, and 5317 funding throughout the State. The areas covered by each subrecipient and the dollars awarded in the past three years should be noted, as well as the number of vehicles, where appropriate. The map or chart should also identify areas where minority and low-income populations exceed the statewide averages.
- d) A demographic profile of the State that includes the identification of the locations of socioeconomic groups, including low-income and minority populations, as covered by Title VI and the Executive Order on Environmental Justice.
- e) HDOT Organization Chart for the Department and for the unit responsible for administration of FTA grant programs.
- f) Sample copies of current funding agreements/contracts between HDOT and its FTA-funded subrecipients, including Section 5309, 5310, 5311, 5316, and 5317 subrecipients.
