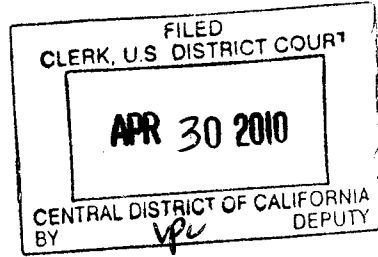

6 2. That the appointment of federal observers by the Director of the Office of
7 Personnel Management is authorized for Riverside County, California, for
8 elections administered by the Riverside County Registrar of Voters, pursuant to
9 Section 3(a) of the Voting Rights Act, 42 U.S.C. § 1973a(a), through March 31,
10 2013.




