MEMORANDUM OF PREHEARING CONFERENCE

On November 6, 1997 at 9:30 a.m. (EST), a follow up telephonic prehearing conference was held in this matter. Appearing on behalf of the complainant was her newly engaged attorney Orin Alexis, and on behalf of respondent was Regina Alberini Young. Mr. Alexis was advised to file his Notice of Appearance in this matter.

At the time of the preliminary prehearing conference, neither party was represented by counsel. Although some discovery was initiated it appears that additional requests will be necessary. Both parties agreed to submit their supplemental discovery requests within thirty (30) days of the prehearing conference.

Respondent will file a motion to correct the designation of its name in the caption, and the complainant agreed not to oppose such a motion. Both parties were strongly encouraged to engage in a good faith settlement dialog.

An additional prehearing conference will be scheduled after at least sixty days when the parties will have had an opportunity to complete their supplemental discovery.
