MEMORANDUM OF PREHEARING
CONFERENCE AND SCHEDULING ORDER

On October 16, 1996 at 11 a.m., a prehearing conference was held in this matter. Appearing on behalf of the complainant was D. Reeves Carter and on behalf of the respondent, Lawrence M. Wilens substituting for Spiro Serras, counsel of record, who was unavailable for the prehearing conference as because of an emergency court appearance. Mr. Wilens did not have before him the file on this matter and thus was unable discuss details of the case.

Because the complaint alleges October 31, 1996 as the date on which a Notice of Intent to Fine was originally served on respondent, complainant orally moved to amend it to substitute October 31, 1995 as the date of service, since the original date was a typographical error. I indicated my intent to allow the motion to amend to reflect October 31, 1995 as the date of service, subject to Mr. Serras' right to file any written objections to the amendment within 10 days. Mr. Wilens was not in a position to either object or stipulate to the motion without the case file.

A telephonic settlement discussion is scheduled between the parties on October 17, 1996, at 2 p.m. In the event settlement is not achieved, both parties will initiate discovery requests within 30 days.
