**ORDER GRANTING MOTION TO DISMISS**  
**(August 24, 1998)**

The Order in this docket dated August 6, 1998, 8 OCAHO 1009, rejected tender of settlement documents as incomplete and inconsistent with the respective roles of the Immigration and Naturalization Service (INS) on the one hand and the Administrative Law Judge on the other hand. Today, August 24, 1998, INS, as complainant, filed a renewed Motion to Dismiss signed by counsel for INS on August 21, 1998. The Motion encloses an underlying Settlement Agreement signed on behalf of both parties. The Settlement Agreement, at paragraph 7, cures the deficiency addressed in the prior Order.

Although only the INS signature to the Settlement Agreement is dated, I have no reason to withhold judicial consent to the agreed disposition between the parties. Accordingly, no reason to the contrary appearing, this Order approves the intent of the parties as reflected by the Settlement Agreement.

Respondent will cease and desist from further violations of 8 U.S.C. § 1324a.

The complaint is dismissed, settled.
