SCHEDULING ORDER

On January 15, 1997 at 4:00 p.m. (EST), a follow up telephonic prehearing conference was held in this matter. Appearing on behalf of the complainant were Gita Vahid and J. Stephen Butcher, and on behalf of the respondent was Perry Hirsch. The principal focus of the conference was the ongoing settlement discussions.

Both parties indicated that a settlement agreement is imminent. The parties shall have thirty days from the date of the conference to file written notice of a settlement agreement.

If such notice is not received by February 16, 1998, the stay of discovery shall be dissolved, and the respondent shall have ten days or until February 26, 1998 to respond to the outstanding discovery requests. The complainant will then have thirty days from its receipt of the discovery responses to file any dispositive motions. Respondent shall have an additional thirty days in which to respond to such motions.
