PROPOSED DECISION

This claim against the Government of Cuba, under Title V of the International Claims Settlement Act of 1949, as amended, was presented by DELFIN DELGADO and is based upon the asserted loss, sustained in connection with the ownership of a preferred stock interest in Ferrocarriles Consolidados de Cuba (Consolidated Railroads of Cuba), hereinafter referred to as Consolidated Railroads, and of a participation interest in the Cuban Venezuelan Oil Voting Trust. Claimant has been a national of the United States since birth.

Under Title V of the International Claims Settlement Act of 1949 [78] Stat. 1110 (1964), 22 U.S.C. §§1643-1643k (1964), as amended, 79 Stat. 988 (1965)7, the Commission is given jurisdiction over claims of nationals of the United States against the Government of Cuba. Section 503(a) of the Act provides that the Commission shall receive and determine in accordance with applicable substantive law, including international law, the amount and validity of claims by nationals of the United States against the Government of Cuba arising since January 1, 1959 for

losses resulting from the nationalization, exproprition, intervention or other taking of, or special measures directed against property including any rights or interests therein owned wholly or partially, directly or indirectly at the time by nationals of the United States.

Section 502(3) of the Act provides:

The term 'property' means any property, right or interest including any leasehold interest, and debts owed by the Government of Cuba or by enterprises which have been nationalized, expropriated, intervened, or taken by the Government of Cuba and debts which are a charge on property which has been nationalized, expropriated, intervened, or taken by the Government of Cuba.

On the basis of evidence of record, the Commission finds that claimant is, and since prior to October 13, 1960, has been the owner of 20 shares of 6% Cumulative Preferred Stock, having a par value of \$100.00 each, of the Consolidated Railroads; and further, the Commission finds that claimant is, and since prior to November 23, 1959, has been the owner of 300 units of participation in the Cuban Venezuelan Oil Voting Trust (hereafter referred to as "the Trust").

The record discloses that Consolidated Railroads of Cuba (Ferrocarriles Consolidados de Cuba) was nationalized by Cuban Law 890, published in the Cuban Official Gazette on October 13, 1960. This corporation was organized under the laws of Cuba and does not qualify as a corporate "National of the United States" defined under Section 502(1)(B) of the Act as a corporation or other legal entity organized under the laws of the United States, or any State, the District of Columbia or the Commonwealth of Puerto Rico, whose ownership is vested to the extent of 50 per centum or more in natural persons who are citizens of the United States.

Further, the record discloses that the properties in Cuba owned or controlled by the Trust were nationalized or otherwise taken by the Government of Cuba on November 23, 1959, pursuant to Law No. 635, published on that date. This corporation was organized under the laws of Cuba and does not qualify as a corporate "national of the United States" defined under Section 502(1)(B) of the Act as a corporation or other legal entity organized under the laws of the United States, or any State, the District of Columbia or the Commonwealth of Puerto Rico, whose ownership is vested to the extent CU-1346

of 50 per centum or more in natural persons who are citizens of the United States. In this type of situation, it has been held previously that a stockholder, or the owner of a participation interest in such a corporation, is entitled to file a claim based upon the securities in question, which represent an interest in the losses sustained by a nationalized enterprise within the purview of Section 502(3) of the Act. (See Claim of Parke, Davis, & Company, Claim No. CU-0180, 1967 FCSC Ann. Rep. 33.)

The record discloses that Consolidated Railroads authorized and had outstanding at the time of loss, two classes of stock--(1) 6% Cumulative Preferred Stock of \$100.00 par value, and (2) Common Stock without par value. The record further discloses that the last quarterly dividend paid in full on the preferred stock was that payable on January 1, 1932. The record shows that a partial payment of \$0.50 was made on the quarterly dividend payable on April 1, 1932, and that since that date no preferred stock dividends have been paid. The total arrearage or accumulation of unpaid preferred stock dividends for each share of stock for the period from 1932 to and including October 1, 1960 was \$172.00.

Under the terms of the preferred stock certificates the dividend accumulation is without interest. The certificates further set forth the rights of preferred stockholders upon dissolution, liquidation or cessation as follows:

Preferred shareholders upon dissolution, liquidation or winding up of the Company, shall be entitled to receive out of the net assets of the Company, whether from capital or earnings, the nominal or par value of the preferred shares registered in their names plus accrued and unpaid dividends, if any on such shares;...

Evidence of record and other information available to the Commission disclose that the value of the real property, equipment and other assets of the Consolidated Railroads of Cuba exceeded its total obligation on debts, bonds, preferred stock, accrual certificates, and accrued and unpaid preferred stock dividends.

The Commission thus concludes that the dollar loss sustained in connection with the ownership of a preferred stock interest in the Consolidated

Railroads of Cuba on the date of loss was \$272.00 per share. This amount represents the \$100.00 par value and the \$172.00 accrued and unpaid dividents per share on the date of loss.

Accordingly, in the instant claim, the Commission finds that claimant as holder of 20 shares of the 6% Cumulative Preferred Stock of the Consolidated Railroads suffered a loss in the amount of \$5,440.00 within the meaning of Title V of the Act, as a result of the nationalization of Consolidated Railroads by the Government of Cuba on October 13, 1960. (See Claim of Cora W. Welsh, et al., Claim No. CU-2503).

In determining the value of the interest owned by claimant in the Trust, the Commission has considered information submitted by officers and stockholders of the Trust, balance sheets for the year ended December 31, 1959, the Trust's annual report for that year, and other evidence of record submitted in this and other claims before the Commission. On the basis of the entire record, the Commission concludes that the dollar loss sustained by the Trust on November 23, 1959 was \$1,106,388.76, and that the loss per unit of participation for each of the 9,247,162 units was \$0.11971, or 11.97 cents. (See Claim of Felix Heyman, Claim No. CU-0412.)

Accordingly, in the instant claim, the Commission finds that claimant, as holder of 300 units of participation in the Trust, suffered a loss in the amount of \$35.91 within the meaning of Title V of the Act, when the properties owned or controlled by the Trust were nationalized or otherwise taken by the Government of Cuba on November 23, 1959.

The Commission has decided that in certification of losses on claims determined pursuant to Title V of the International Claims Settlement Act of 1949, as amended, interest should be included at the rate of 6% per annum from the date of loss to the date of settlement. (See Claim of Lisle Corporation, Claim No. CU-0644.)

Accordingly, the Commission concludes that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum as follows to the date on which provisions are made for the settlement thereof:

NOTICE TO TREASURY: The above-referenced securities may not have been submitted to the Commission or if submitted, may have been returned; accordingly, no payment should be made until claimant establishes retention of the securities or the loss here certified.

The statute does not provide for the payment of claims against the Government of Cuba. Provision is only made for the determination by the Commission of the validity and amounts of such claims. Section 501 of the statute specifically precludes any authorization for appropriations for payment of these claims. The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
