PROPOSED DECISION

Claimant, LOUISE CARTWRIGHT, asserts a claim against the Government of Cuba under Title V of the International Claims Settlement Act of 1949, as amended, based upon a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cuba.

In our decision entitled the <u>Claim of Ruth Anna Haskew</u> (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the <u>Haskew</u> decision; that she and her predecessor in interest, Norma Taggart, were American nationals at all requisite times; that Norma Taggart was the owner of 100 shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba from prior to August 6, 1960 until her death in 1965; that claimant inherited the shares at that time; and that she succeeded to a loss in the amount of \$4,639.46 suffered with respect to such shares within the meaning of Title V of the Act.

Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See <u>Haskew</u>, <u>supra</u>.)

CERTIFICATION OF LOSS

The Commission certifies that LOUISE CARTWRIGHT suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Four Thousand Six Hundred Thirty-Nine Dollars and Forty-Six Cents (\$4,639.46) with interest at 6% per annum from August 6, 1960 to the date of settlement.
