PROPOSED DECISION

Claimant, JOHANNA THALHEIMER, who owned a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cuba, asserts a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the Claim of Ruth Anna Haskeu (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant claim, the Commission finds that claimant herein and her late husband, Martin Thalheimer, nationals of the United States at all pertinent times, were the owners, as joint tenants, of 100 shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba since prior to August 6, 1960; and that they suffered a loss in the amount of \$4,639.46 within the meaning of Title V of the Act, within the terms of the Haskeu decision. Further, the Commission finds that when Martin Thalheimer died on May 5, 1961, claimant herein became the surviving and sole owner of the claim for such loss; and that the amount of loss sustained herein

shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Haskew, supra.)

CERTIFICATION OF LOSS

The Commission certifies that JOHANNA THALHEIMER succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Four Thousand Six Hundred Thirty-nine Dollars and Forty-six Cents (\$4,639.46) with interest at 6% per annum from August 6, 1960, to the date of settlement.

Section 501 of the statute specifically precludes any authorization for appropriations for payment of these claims. The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
