PROPOSED DECISION

Claimant, JOSEPHINE WOOD, ADMINISTRATRIX OF THE ESTATE OF JOHN S. WOOD, DECEASED, who owned a stock interest in the Cia. Azucarera Vertientes-Camaguey de Cuba, asserts a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the Claim of Ruth Anna Haskew (Claim No. CU-0849 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$46.3946.

On the basis of evidence in the record in the instant case, the Commission finds that John S. Wood died in 1955, that JOSEPHINE WOOD is Administratrix of his Estate and beneficiary of his estate with respect to the subject matter of this claim; that she comes within the terms of the Haskew decision; that she was an American national at the requisite times; that she has been the beneficial owner of 10 shares of stock in the Cia. Azucarera Vertientes-Camaguey de Cuba since prior to August 6, 1960; and that she suffered a loss in the amount of \$463.95 within the meaning of Title V of

the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Haskew, supra.)

CERTIFICATION OF LOSS

The Commission certifies that JOSEPHINE WOOD, ADMINISTRATRIX OF THE ESTATE OF JOHN S. WOOD, DECEASED, succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Four Hundred Sixty-three Dollars and Ninety-five Cents (\$463.95) with interest at 6% per annum from August 6, 1960 to the date of settlement.

The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
