PROPOSED DECISION

Claimant, SYLVIA R. AMSTER, who owned a preferred stock interest in The Cuba Railroad Company, asserts a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Railroad.

In our decision entitled the <u>Claim of Irwin Nack</u>, et al. (Claim No. CO-1960 which we incorporate herein by reference), we held that the properties owned by the Railroad were nationalized or otherwise taken by the Government of Guba on October 13, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per preferred share of \$100.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the <u>Nack</u> decision; that she was an American national at the requisite times; that she has been the owner of 100 shares of preferred stock in The Cuba Railroad Company since prior to October 13, 1960; and that she suffered a loss in the amount of \$10,000.00 within the meaning of Title V of the Act. Further the Comclassion finds that the amount of loss sustained shall be increased by inversest thereon at the rate of 6% per annum from October 13, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Nack, supra.)

CERTIFICATION OF LOSS

The Commission certifies that SYLVIA R. AMSTER suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the emount of Ten Thousand Dollars (\$10,000.00) with interest at 6% per annum from October 13, 1960 to the date of settlement.
