PROPOSED DECISION

Claimants, ERWIN RUEGGE AND HERBERT F. RUEGGE, EXECUTORS OF THE ESTATE OF THEODORE RUEGGE, DECEASED, who cwned a "Belen" bond issued by the Association of the Religious Community of the Company of Jesus of Bethlehem College of Havana, assert a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the <u>Claim of Gustavus Basch</u> (Claim No. CU-0972 which we incorporate herein by reference), we held that the properties of the College were nationalized or otherwise taken by the Government of Cuba on May 3, 1961, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per \$1,000 bond of \$459.17 including interest to May 3, 1961.

On the basis of evidence in the record in the instant case, the Commission finds that claimants come within the terms of the <u>Basch</u> decision; that decedent who died in 1954 and all the beneficiaries of his estate have been American nationals at the requisite times; that decedent, prior to his death, had been the owner of the Belen bond in question; and that claimants succeeded to and suffered a loss in the amount of \$459.17 within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from May 3, 1961, the date of loss, to the date on which provisions are made for the settlement thereof. (See <u>Basch</u>, <u>supra</u>.)

The Commission has decided that in certification of losses on claims determined pursuant to Title V of the International Claims Settlement Act of 1949, as amended, interest should be included at the rate of 6% per annum from the date of loss to the date of settlement (see <u>Claim of Lisle</u> <u>Corporation</u>, Claim No. CU-0644), and in the instant case it is so ordered. CERTIFICATION OF LOSS

The Commission certifies that ERWIN RUEGGE AND HERBERT F. RUEGGE, EXECUTORS OF THE ESTATE OF THEODORE RUEGGE, DECEASED, succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Four Hundred Fifty-Nine Dollars and Seventeen Cents (\$459.17) with interest at 6% per annum from May 3, 1961 to the date of settlement.
