

**2011 APPROPRIATION LANGUAGE CHANGES**

**Department of Justice**

The information provided below describes substantive changes from the Department of Justice Appropriations Act for 2010. Changes such as new funding levels, changes in the number of motor vehicles, changes in references to fiscal years, minor program name changes, and deletion of references to emergency funding designations and prior year rescissions are not discussed.

<b>Program</b>	<b>Language Changes</b>
General Administration, Salaries and Expenses	Adds language to provide funding for terrorism prosecutions and related costs and allow for the transfer of funding for terrorism prosecutions and related costs to other Department of Justice accounts. Deletes language specifying funding levels for certain offices within the GA appropriation to provide flexibility within the GA account to adapt to administration priorities. Adds two provisos allowing for the movement of funds between programs within GA and stating that this transfer authority is in addition to our 505 reprogramming authority.
Law Enforcement Wireless Communications	Deletes the word "Tactical" from the appropriation title, consistent with common usage of the program name.
Justice Information Sharing Technology	Adds language to specify funding available for the Unified Financial Management System.
National Drug Intelligence Center	Deletes language specifying the amount made available for reimbursement for Air Force personnel.
United States Attorneys, Salaries and Expenses	Deletes the language requiring not less than \$36,980,000 to hire Assistant U.S. Attorneys to carry out section 704 of the Adam Walsh Act of 2006. Deletes language providing \$6,000,000 for prosecutions of serious crime in Indian Country.
United States Marshals Service	Decreases funding for official reception and representation expenses from \$30,000 to \$6,000.
Assets Forfeiture Fund	Adds language to permanently cancel unobligated balances of \$495,000,000.
Federal Bureau of Investigation, Salaries and Expenses	Deletes language designating \$101,066,000 for Overseas Contingency Operations. Deletes language authorizing the Director of the Federal Bureau of Investigation to transfer up to \$30,000,000 from this account to the Construction account for the Biometrics Technology Center.
Federal Bureau of Investigation, Construction	Adds language to authorize construction funds to be used for the operation and maintenance of secure work environment facilities and secure networking capabilities. Adds language to permanently cancel unobligated balances of \$98,886,000.
Drug Enforcement Administration, Construction	Creates a separate appropriation line for construction funds.
Bureau of Alcohol, Tobacco, Firearms and Explosives, Salaries and Expenses	Increases not to exceed language to \$20,000,000 in no-year authority.
Bureau of Alcohol, Tobacco, Firearms and Explosives, Construction	Deletes the separate appropriation line for construction funds.
Office of Justice Programs	For Salaries and Expenses: Adds language for a small portion of Salaries and Expenses funds for peer review costs to remain available until September 30, 2012.  For Justice Assistance: Adds language to expressly include activities authorized under subtitle D of title II of the Homeland Security Act of 2002. Adds language for a program to prosecute, prevent, and otherwise combat hate crimes, including related research. Adds language for a program to support a help desk and diagnostic center.  For State and Local Law Enforcement Assistance: Adds the NICS Improvement Amendments Act of 2007 to the list of authorizations. Adds the Homeland Security Act of

2002 to the list of authorizations. Adds provisos relating to subtitle D of title II of the Homeland Security Act of 2002. Adds a proviso relating to reimbursement costs associated with the housing of Federal immigration and other detainees in State and local detention facilities. Deletes language pertaining to the Southwest Border Prosecutor Initiative. Deletes language pertaining to discretionary grants to improve the functioning of the criminal justice system, to prevent or combat juvenile delinquency, and to assist victims of crime (other than compensation). Deletes language pertaining to the Missing Alzheimer's Disease Patient Alert Program (section 240001 of the 1994 Act). Deletes language pertaining to Drug Courts, as authorized by section 1001(25)(A) of title I of the 1968 Act. Deletes language pertaining to a program to monitor prescription drugs and scheduled listed chemical products. Deletes language pertaining to mental health courts and adult and juvenile collaboration program grants, as authorized by parts V and HH of title I of the 1968 Act, and the Mentally Ill Offender Treatment and Crime Reduction Reauthorization and Improvement Act of 2008 (Public Law 110-416. Deletes language pertaining to assistance to Indian tribes, including grants under section 20109 of subtitle A of title II of the 1994 Act; Tribal Courts Initiative; tribal alcohol and substance abuse reduction assistance grants; and training and technical assistance and civil and criminal legal assistance as authorized by title I of Public Law 106-559. Deletes language pertaining to economic, high technology and Internet crime prevention grants, including as authorized by section 401 of Public Law 110-403. Deletes language pertaining to analysis and research on violence against Indian women, including as authorized by section 904 of the 2005 Act. Deletes language pertaining to grants for televised testimony, as authorized by part N of title I of the 1968 Act. Deletes language pertaining to programs to reduce gun crime and gang violence. Adds language that provides funding for offender re-entry programs, research, and statistics, as authorized by the Second Chance Act of 2007, including funding for research programs. Adds language that provides funding for drug, mental health, and problem-solving courts. Adds language that provides funding for an initiative to assist and support evidence-based policing. Adds language that provides funding for technical and other targeted assistance to improve the functioning of the criminal justice system. Adds language that provides funding for a justice information sharing and technology program. Adds language that provides funding for implementation of the Adam Walsh Act, including sex offender management assistance and the National Sex Offender Public Website. Adds language that provides funding for a program to improve state, local, and tribal probation supervision efforts and strategies. Adds language that provides funding for an initiative relating to children exposed to violence. Adds language that provides funding for a criminal justice innovation program. Adds language that provides funding for DNA-related and forensic programs and activities (including related research and development, training and education, and technical assistance). Adds language that provides funding for the matching grant program for armor vests, as authorized by section 2501 of title I of the 1968 Act and for related research, testing, and evaluation programs and for technical support.

For Weed and Seed Program Fund: Deletes language pertaining to the Office of Weed and Seed Strategies.

For Juvenile Justice Programs: Deletes language pertaining to grants and projects, as authorized by sections 261 and 262 of the 1974 Act. Deletes language pertaining to the Tribal Youth Program; gang education initiative; and discretionary grants, for programs and activities to enforce State laws prohibiting the sale of alcoholic beverages to minors or the purchase or consumption of alcoholic beverages by minors, for prevention and reduction of consumption of alcoholic beverages by minors, and for technical assistance and training. Deletes language pertaining to the Safe Start Program, as authorized by the 1974 Act. Adds language that provides funding for a juvenile delinquency court improvement program. Adds language that provides funding for a disproportionate minority contact evaluation and pilot program. Adds language that provides funding for gang and youth violence prevention and intervention and related initiatives. Adds provisos relating to section 2991(e) of title I of the 1968 Act and section 530A of title 28, United States Code.

<p>Community Oriented Policing Services</p>	<p>Removes authorization statutes for programs not being requested under COPS account. Removes restriction on use of prior year deobligated balances to make them available for obligation. Removes language on OJP-administered program not requested under COPS account. Eliminates funding for the COPS Methamphetamine program. Eliminates funding for the COPS Law Enforcement Technology program. Removes language on OJP-administered program not requested under COPS account. Request adds \$15 million for the COPS Police Integrity program. Institutes a 10 percent local share matching requirement for the COPS Hiring Program in FY 2011. Sets aside \$42 million from the COPS Hiring Program to be used to fund the hiring of tribal law enforcement officers. Adds language to rescind \$10.2 million from COPS prior year unobligated balances and adds language that prohibits cancellation of amounts designated by Congress as an emergency requirement pursuant to the Concurrent Resolution on the Budget or the Balanced Budget and Emergency Deficit Control Act of 1985.</p>
<p>Office on Violence Against Women</p>	<p>Transitional Housing and NIJ Research are moved as their own separate line items rather than displayed as set-asides within the STOP Program.  Eliminated request for programs that are administered by OJP because it is more appropriate and efficient for OJP to request these items directly.  Includes a request for additional funding for a clearinghouse on sexual assault of American Indian and Alaska Native women and regional summits on violence against women in Indian Country.  Eliminates language related to the Supporting Teens Through Education Program, as it was appropriated in the FY 2010 bill and is not included in the FY 2011 budget request.</p>
