PROPOSED DECISION

This is a claim under Section 303(2) of the International Claims Settlement Act of 1949, as amended, for \$27,901.26 by JENO HARTMANN, a national of the United States since his naturalization in the United States on July 23, 1946, for the nationalization, compulsory liquidation, or other taking of property in Hungary.

The Commission finds that the claimant was the owner of a plot of land at 6 Epreskert Street, Nyiregyhaza, improved with a building containing living quarters and a bakery consisting of installed equipment, and furnishings, all of which belonged to claimant, although the business was conducted by another, to whom any profits belonged. The Government of Hungary nationalized the bakery on January 6, 1950, under the provisions of Hungarian Law-Decree 1949:20 tvr. (Official Gazette, December 28, 1949).

The operation of the bakery by the Government of Hungary is made possible only through the use of the claimant's real property, for which he has received no compensation. Although the Government of Hungary has stated that title to the real estate in question has not been taken into state ownership, it is hard to conceive of a more effective method of taking of property than appears in the instant case with respect to claimant's realty. Claimant has been prohibited from

entering upon his property, from using and enjoying it, and from alienating it. Accordingly, while the method of taking of claimant's realty utilized in the present situation, leaves the claimant endowed with the indicia of ownership, the Commission nevertheless finds that such realty has been effectively taken from claimant within the meaning of Section 303(2) of the International Claims Settlement Act of 1949, as amended.

The Commission further finds that the value of the property so taken from the claimant was Seven Thousand Five Hundred Dollars (\$7,500.00) and concludes that claimant is entitled to an award under Section 303(2) of the Act.

AWARD

Pursuant to the provisions of the International Claims Settlement Act of 1949, as amended, an award is hereby made to JENO HARTMANN
in the amount of Seven Thousand Five Hundred Dollars (\$7,500.00) plus
interest at the rate of 6% per annum from January 6, 1950 to August 9,
1955, the effective date of the Act, in the amount of Two Thousand Five
Hundred Sixteen Dollars and Twenty Eight Cents (\$2,516.28).

Payment of any part of this award shall not be construed to have divested the claimant herein, or the Government of the United States, on his behalf, of any rights against the Government of Hungary for the unpaid balance of the claim, if any.
