

PROPOSED DECISION OF THE COMMISSION

This is a claim for "between \$18,000 and \$20,000 by Drago Nenadich, a citizen of the United States since January 5, 1945, and is for the nationalization by the Government of Yugoslavia of (1) "Treska A. D." a Yugoslav company trading in finishing wood, in which claimant owned 20 shares of stock at that time; (2) Kingdom S. H. S. State Loan bonds - Series 25644, No. 51-100, and (3) bank deposits in the Yugoslav State Post Office Savings, Belgrade; Franco Serb Bank, Belgrade; Serbian Central Trade Bank at Sarajevo, and the Serbian Central Bank at Sarajevo.

This decision will be limited to the claim for the stocks

and bonds. The claim for the bank deposits was disposed of prior hereto by Proposed Decision No. 336, which decision became final on September 11, 1952.

Claimant has filed no evidence as to his ownership of the 20 shares of stock in "Trska A. D." or the nationalization of that company by the Government of Yugoslavia although he was invited to do so. However, he did request the Commission to endeavor to obtain the same through its investigator and the Government of Yugoslavia. Investigators from this Commission and the Government of Yugoslavia informed the Commission that "Treska" was confiscated on
