#### **NCFS Directive Recommendation**

Purpose for gathering information on entities providing forensic services:

 to determine the impact of recommending accreditation requirement for forensic service providers

What makes up the universe of forensic service providers?

- 1. Publicly-funded labs
- 2. Law enforcement agencies
- 3. Private labs

## Summary of survey platform

The system is designed to:



- Conduct ongoing data collection from a nationally representative sample of law enforcement agencies;
- Field surveys that are short (approximately 30 questions; burden of 20 minutes or less) and provide findings within 6 months of initial survey administration;
- Collect and distribute information through an interactive website.

## Specific elements for survey

- 1. Which law enforcement agencies are performing forensic services in their facilities?
  - Choose services from pick-list of options
- 2. Is the lab accredited? By what body?
- 3. Does the LEA require that analysts are certified? By what body?
- 4. Among LEAs with an internal facility, how many analysts do they employee in each discipline
- 5. What areas of forensic services does the LEA NOT cover?
  - Where do they send items for processing?

#### Specific elements for survey

- 6. Number of <u>cases</u> for which the LEA provided forensic services during the reference period
  - Need to define "case"
- 7. Number of facilities with which the LEA contracts
  - Commercial facilities
  - Public facilities
- 8. If state lab is available, reasons why the LEA does not use it
  - Provide pick-list of reasons (Too long to process, too costly per specimen, etc.)
- 9. Funding for services

# Additional issues to consider for survey

What additional information is needed to assess the impact of establishing accreditation and/or certification standards for LEAs?

- Backlogs?
- Cost to agencies?
- Amount of staff time required for accreditation and/or certification?
- Measures to determine how evidence processing burden will shift to other labs?
- Other information?

#### **Next steps**

- 1. Work with Commission members to develop survey instrumentation Spring 2015
- 2. Test and finalize survey instrumentation Summer 2015
- 3. Explore options for surveying federal law enforcement agencies regarding forensic services Summer 2015
- 4. Engage in discussions with other federal agencies (i.e. NCHS) about identifying forensic services provided by MEs and coroners Summer 2015
