THE GRAND JURY CHARGES:

COUNTS ONE THROUGH TWENTY-FIVE

[26 U.S.C. § 7206(2) – Aiding and Assisting in the Preparation and  
Presentation of a False and Fraudulent Return]

1. That on or about the dates hereinafter set forth, in the Columbus Division of the Middle District of Georgia, the defendant,

GREGORY L. CARTER,

a resident of Columbus, Georgia, did willfully aid and assist in, and procure, counsel, and advise the preparation and presentation to the Internal Revenue Service, of U.S. Individual Income Tax Returns, Forms 1040, either individual or joint, for taxpayers whose identities are known to the grand jury and for the calendar years hereinafter specified. The returns were false and fraudulent as to material matters, in that they represented that the taxpayers were entitled under the provisions of the Internal

Revenue laws to claim deductions or credits for items and in amounts hereinafter specified, whereas, as the defendant then and there knew, the taxpayers were not entitled to claim deductions or credits in the claimed amounts.

2. The allegations of paragraph 1 are repeated and realleged in Counts One through Twenty-Five, inclusive, of this Indictment, as though fully set forth therein:
