DOJ Response to IC Crime

- 94 federal judicial districts
- 93 United States Attorneys Presidentially Appointed and Senate Confirmed
- 44 Federal Judicial Districts have federally recognized tribes (include PL 280 jurisdictions)
 - Major Crimes Act
 - General Crimes Act
 - Assimilative Crimes Act
 - Federal Crimes of General Applicability

Children Exposed to Violence – Attorney General Priority

- National Survey of Children's Exposure to Violence measured the past-year and lifetime exposure to violence for children age 17 and younger
- Year prior to being interviewed
 - 1 in 20 witnessed someone being shot
 - 1 in 200 witnessed a murder
 - 1 in 50 sexually assaulted
- More than 60% of children surveyed were exposed to violence with the past year, either directly or indirectly
- Solicitation closed on June 1st will fund 8 sites to plan for CEV project: will include tribal sites.

DAG Memo 1/11/10

- "Public safety in tribal communities is a top priority for the Department of Justice."
- "I direct every USAO with IC in its district to engage annually, in coordination with our law enforcement partners, in consultation with the tribes in that district.
- "I direct all such USAOs to develop an operational plan addressing public safety in IC."
 - Within 8 months of new USA taking office and review and update annually

More DAG Memo

- "Addressing violence against women and children in IC is a Department of Justice priority."
- "The Department, through the USAOs, has a duty to investigate and prosecute serious crimes in IC, including crimes against women and children."
- "Reports of sexual assault or domestic violence in IC should be investigated wherever credible evidence of violations of federal law exists, and prosecuted when the Principles of Federal Prosecution are met."

More DAG Memo

- "Where federal jurisdiction exists, the responsibility to investigate and prosecute violence against women in IC also extends to misdemeanor assaults committed by non-Indian offenders against Native American women on federally recognized reservations."
- "Due care should be exercised to recognize ongoing risks to victims in sexual assault and domestic violence cases, and to expeditiously make charging decisions in high-risk cases to minimize or eliminate those risks."

DAG Memo Concluded

- "In developing district-specific operational plans for public safety in tribal communities, I direct every U.S. Attorney to pay particular attention to violence against women, and to work closely with law enforcement to make these crimes a priority."
- "The Department has a responsibility to build a successful and sustainable response to the scourge of violent crime on reservations."

Operational Plan Guidance

- Plans should address the following core components:
 - Communication
 - Investigations
 - Victim advocacy
 - Training
 - Outreach
 - Violence against women
 - Accountability

Communication

 Describe the process for informing tribal law enforcement about charging decisions

Investigations

- Child Protection or Multidisciplinary Teams convened to investigate or provide case management for child abuse and/or child sexual abuse cases.
- 18 United States Code 3509(g)

Training

- A plan for conducting a training needs assessment for federal, state, and tribal law enforcement.
- A strategy to meet the training needs of federal, state, and tribal law partners.

Violence Against Women

Sexual Assault Cases

- Ensure medical professionals and law enforcement personnel have rape kits available
- Victims have access to competent and compassionate medical professionals with the requisite skill to perform medical examinations
- Accredited labs to timely analyze rape kits and other forensic evidence
- Evaluation of existing MOUs that assign responsibility to federal agencies for investigating sexual assault cases

EOUSA Federal Domestic Violence Crimes Training DVD

- Funded by OVC
- Working group meeting on November 17-18, 2009
- Topics to be included: elements of federal offenses, safety planning and lethality assessment, pre-trial release considerations and sentencing options.
- Ongoing efforts to identify cases to highlight and victims, law enforcement, prosecutors, advocates and others to interview
- Target release date = Summer/Fall 2010
