6 and such visual depictions were of such conduct, all in violation of
7 Title 18, United States Code, Section 2252(a)(2).

8 FORFEITURE ALLEGATION: [18 U.S.C. § 2253(a) - Criminal Forfeiture]

9 1. Upon conviction of the offense alleged in this Indictment,
10 defendant JOHN HURLEY WOOD shall forfeit to the United States
11 pursuant to 18 U.S.C. § 2253(a), any and all matter which contains
12 visual depictions produced, transported, mailed, shipped or received
13 in violation thereof; any property, real or personal, constituting or
14 traceable to gross profits or other proceeds the defendant obtained
15 as a result of the said violations; and any property, real or
16 personal, used or intended to be used to commit and promote the
17 commission of the violations, including, but not limited to:

- 18 a. one HP Pavilion Tower, serial number 3CR92800JH;
19 b. one Seagate external disk drive, serial number 2GHM8KQ1;
20 and
21 c. one Seagate external disk Drive, serial number 2HCJ083D.

22 2. If any property subject to forfeiture as a result of the
23 offense alleged in this Indictment for which defendant is convicted:


- 24 a. cannot be located upon the exercise of due diligence;
25 b. has been transferred or sold to, or deposited with, a
26 third party;
27 c. has been placed beyond the jurisdiction of the Court;
28 d. has been substantially diminished in value; or

1 e. has been commingled with other property which cannot be
2 divided without difficulty;
3 it is the intent of the United States, pursuant to 18 U.S.C.
4 § 2253(b), incorporating 21 U.S.C. § 853(p), to seek forfeiture of
5 any other property of said defendant, up to the value of the property
6 subject to forfeiture.
