SARASOTA MAN SENTENCED TO 22 YEARS FOR ATTEMPTING TO INDUCE A MINOR FOR SEX

Tampa, Florida - U.S. Attorney Robert E. O'Neill announces that U.S. District Judge Richard A. Lazzara today sentenced Timothy Scott Bidwell (49, of Sarasota) to 22 years in federal prison for using the internet in an attempt to induce and persuade a minor to engage in sex acts with him. The court also ordered Bidwell to forfeit a computer that prosecutors alleged was used in the commission of the offense.

Bidwell was convicted by a jury on February 18, 2011. According to court documents and evidence presented at trial, Bidwell posted an ad on an internet website soliciting a mother who was willing to share her daughter for sex. For two days, Bidwell communicated online via email and instant chat messages with an undercover detective, who Bidwell believed to be a mother willing to allow him to have sex with her 11- and 14-year-old daughters. In these graphically detailed communications, Bidwell repeatedly described the sex acts he wished to perform with the children. He was arrested by the authorities on August 24, 2010, when he traveled from Sarasota to Clearwater to meet, who he believed to be, the mother and daughters to engage in the sexual activity.

This case was investigated by the Pinellas County Sheriff's Office and the U.S. Immigration and Customs Enforcement's Homeland Security Investigations. It was prosecuted by Assistant United States Attorneys Amanda C. Kaiser and Josephine W. Thomas.

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by United States Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section (CEOS), Project Safe Childhood marshals federal, state, and local resources to better locate, apprehend, and prosecute individuals who exploit children via the Internet, and to identify and rescue victims. This case was also part of Operation Predator, a nationwide ICE initiative to identify, investigate, and arrest those who prey on children, including human traffickers, international sex tourists, Internet pornographers, and foreign-national predators whose crimes make them deportable.
