**SOUTH FLORIDA WOMAN  
SENTENCED FOR MEDICARE FRAUD**

**SAVANNAH, GA:** Edmund A. Booth, Jr., United States Attorney for the Southern District of Georgia, announced today that a South Florida woman, who is a citizen of Cuba, has been sentenced in U.S. District Court in Savannah by U.S. District Judge B. Avant Edenfield for her conviction on participation in a local health care fraud conspiracy. Aurora Yvette Hernandez, age 46, was sentenced to 51 months imprisonment in connection with a scheme to defraud Medicare by billing for \$3.4 million of phony infusion services which were never provided. Hernandez was remanded to the custody of the United States Marshal Service after her sentence was imposed.

Booth stated that evidence presented by Assistant United States Attorney Brian McEvoy in the sentencing established that in April, 2007, Hernandez opened a business called "Longevity Care Services." Hernandez, through Longevity Care Services, then submitted bills to Medicare for fictitious infusion services on behalf of the recruited Medicare patients. Infusion services, when properly performed, are used to treat patients with immuno-compromised conditions such as AIDS and cancer.

Booth stated that “law enforcement nationwide are targeting phony infusion clinics and that such illegal activity in this District will be quickly investigated and prosecuted. The government is committed to combating health care fraud and abuse in our community.”

Booth praised the work of agents with the Federal Bureau of Investigation and the Department of Health and Human Services who investigated the case. The government was represented by Assistant United States Attorney Brian McEvoy.
