

31 SCHWEIHS Well did the guy leave a name or
32 something?
33
34 WEMETTE No, and I wouldn't go downstairs. I
35 would not go downstairs. But I've been
36 fighting with...
37
38 SCHWEIHS When did this guy come here?
39
40 WEMETTE When I called you. I called you right
41 away, but I couldn't get ya. Ahh, fuck
42 Frank, my my, it ah, it's gotta be two
43 weeks ago. A week, ya know, two weeks
44 ago. It was, it was...
45
46 SCHWEIHS Sure the guy ain't a fuckin' copper.
47
48 WEMETTE Can't be no fuckin' copper.
49
50 SCHWEIHS Undercover copper.

4 come here. What did he want to know

21

33 this cunt lapper?
34
35 WEMETTE He's gonna be carrying a stick 'cause I
36 ain't fuckin' around.
37
38 SCHWEIHS I mean this guy say when he's coming
39 back, this jagoff.
40
41 WEMETTE Fuck no.
42
43 SCHWEIHS Wants to know who your partner is.
44
45 WEMETTE Fuck no.
46
47 SCHWEIHS Yeah.
48

3 SCHWEIHS You want this sign off your property,
4 right? You think she's with somebody?
5 Who do you think she's with?
6
7 WEMETTE Mike Glitta.
8
9 SCHWEIHS Save me a lot of fuckin' time.
10
11 WEMETTE Mile Glitta.
12
13 SCHWEIHS She is with him.
14
15 WEMETTE No I think.
16
17 SCHWEIHS You think she's with...
18
19 WEMETTE I don't know if he took a piece of her
20 or not. Like I said, ya know, there was
21 a supposed bomb that was suppose to go
22 off, and then all of a sudden
23 everything's cool. Did he back off of
24 her, or did he take her?

3 SCHWEIHS You think he's, he's tied in with her,
4 right? That's your opinion.
5
6 CROSS Right.
7
8 SCHWEIHS We don't know that for a fact.
9
10 WEMETTE Well they had an altercation.
11
12 SCHWEIHS That's okay. Nothing showing up on her
13 this mother fucker.
14
15 CROSS Well she's got a penthouse over one, or
16 not a penthouse a townhouse. (UI)
17
18 SCHWEIHS Well if this guy come here...no one
19 knows what he looks like or anything,
20 right?
21
22 WEMETTE I didn't go down.
23
24 SCHWEIHS Yeah?
25
26 WEMETTE I was here.
27
28 SCHWEIHS What did he ask the clerk? He wanted to
29 know who, who owns the joint.
30
31 WEMETTE He says get the owner down here. So he
32 knew I was upstairs. And so the guy
33 calls on the answering service and says
34 there somebody here, and I said, I just
35 didn't pick up the phone. Then I waited

7 something he ain't looking for. Ah, if
8 the guy comes back...

10 WEMETTE (LAUGHS)
11
12 SCHWEIHS If the guy comes back, here's all you
13 tell him. Listen, I don't know who the
14 fuck you are. It's none of your fuckin'
15 business who owns the joint. And go
16 where the fuck you want to go with it.
17 That's exactly what I want you to tell
18 him, Lenny.
19
20 CROSS No problem. That's exactly what I'll
21 tell 'em.
22
23 SCHWEIHS Tell him look it.
24
25 WEMETTE Lenny.
26
27 SCHWEIHS (UI).
28
29 WEMETTE (UI).
30
31 SCHWEIHS Just tell the guy real nice, say listen,
32 it's none of your business who owns this
33 joint. Okay? Now you go where the fuck
34 you want to go with that. Okay?
35
36 CROSS No problem that's exactly what I'll tell
37 him.
38
39 SCHWEIHS Okay. Let's see where he wants to go.
40 Okay? If he's a fuckin' undercover
41 copper, where's he gonna go with it.
42 Nowhere. And if he's a fuckin' wise guy
43 he's gotta go back to somebody and then
44 we're gonna find out who the fuck he is,
45 and what the fuck business has he got
46 coming over here and inquiring who owns
47 the joint. That's the only way we're
48 gonna flush him. As long as he ain't

1 leaving his name. Just tell him in a
2 real nice fuckin' cold way. Listen,
3 it's none of your business who owns the

7 CROSS No problem.
8
9 SCHWEIHS Okay. Bring it where you want to bring
10 it, buddy, but don't come back here.
11
12 WEMETTE Tough him out.
13
14 SCHWEIHS Ah, yeah, it's none of your business who
15 owns this fuckin' joint.
16
17 WEMETTE If we have a physical altercation.
18
19 SCHWEIHS Let's see if he's (UI) with this Mike.
20
21 WEMETTE If he has a physical
22
23 SCHWEIHS There's no way this jagoff would be with
24 this Mike.
25
26 WEMETTE If we have a physical altercation with
27 this gentleman.
28
29 SCHWEIHS I give a fuck what you do to him.
30 That's his fuckin' problem. First of
31 all, he ain't suppose to come. First of
32 all, this guy can't be with no one
33 'cause if he was with someone they would
34 of never send him over here and inquire
35 about this joint. They know this joint
36 is spoken for.
37
38 WEMETTE Well should I call the police?
39
40 SCHWEIHS No it can't be Mike. Nah. It could be
41 some fuckin'...
42
43 WEMETTE If he's an undercover cop I can always
44 dial 911, say I got somebody here
45 bothering me.
46
47 SCHWEIHS Nah, it could...no don't do that. Ya
48 know, 'cause it's like beefing. This

1 Frank, there's a couple of fuckin'
2 joints running this district over here.
3 I'm gonna go make a move on 'em. I'm
4 gonna say what, where, on Wells Street
5 or on Clark Street. Get the, forget
6 about it. Don't even go near the
7 fuckin' joint.
8
9 WEMETTE It's spoken for.
10
11 SCHWEIHS I, don't tell the guy that it's none of
12 his business. If I tell him forget
13 about it, forget about it, he don't have
14 to know who the fuck's got the joints or
15 who's affiliated with 'em or what's
16 going down. It's none of their
17 business. The less these mother fuckers
18 know our business the better off it's
19 gonna be. This guy that come here gotta
20 be either an undercover copper with this
21 task force trying to find out who owns
22 these joints, or is the fuckin', fuckin'
23 jagoff you had working for ya. Woulda
24 said yeah, it's a fuckin' syndicate
25 joint. Get the fuck out of here.
26 That's what they want these assholes to
27 say.
28
29 WEMETTE (UI).
30
31 SCHWEIHS You know what I'm trying to say, Lenny.
32
33 CROSS (UI).
34
35 WEMETTE The kid got scared and quit.
36
37 SCHWEIHS Yeah.
38
39 WEMETTE Quit right on the spot. He was scared.
40
41 SCHWEIHS You know what I mean? I gotta say it's
42 an undercover copper probing.
43
44 WEMETTE (UI).
45
46 SCHWEIHS Ya know they're going in all these
47 joints like, ya know, what it is they're
48 putting the ruse on that, they're tough

1 guys that they're with the Outfit, and
2 they're armin' joints. They ain't with
3 no fuckin' Outfit. They're on the (UI).
4 They're waiting for you to fuckin' blow
5 your top and say hey, this is a
6 connected joint. Stay the fuck out of
7 here. You know what I mean?
8
9 WEMETTE (UI).
10
11 SCHWEIHS That's why use the words the way I
12 explain to you. This prick...
13
14 CROSS (UI).
15
16 SCHWEIHS Listen, it's none of your fuckin'
17 business who owns this fuckin' business,
18 and stay the fuck out of here. And go
19 where the fuck you want to bring that.
20 Go back to where ever you come from with
21 it.
22
23 WEMETTE Usually I just say I'm the landlord
24 here.
25
26 SCHWEIHS No, you don't have to tell 'em nothing.
27
28 CROSS I won't tell 'em shit.
29
30 SCHWEIHS Just say it's none of your fuckin'
31 business who owns the business. Who
32 owns it...there's a license on the wall.
33 He wants to take the name off the
34 license, fine.
35
36 WEMETTE He ain't getting that license.
37
38 SCHWEIHS No, but I'm saying if he does, that's
39 fine. If he's...
40
41 WEMETTE He ain't getting the licenses unless
42 he's got a badge.
43
44 SCHWEIHS Right. That's what I'm trying to say.
45 Now if he don't come up with a badge you
46 don't know who the fuck he is. So you
47 just tell 'em in fuckin' stern way, hey,
48 it's none of your fuckin' business who

1 owns the joint. Okay? Now don't come
2 around here again. And go fuckin' where
3 you want to go with it. Bring it
4 wherever you want to bring it, prick.
5
6 CROSS (UI) come up.
7
8 SCHWEIHS Right. Now if he is with somebody he's
9 gonna run back and say, hey, fuck these
10 guys. This what they told me, this and

4 the joint, that owns the joint, say it's
5 none of your business who owns the
6 fuckin' joint. Ya know, and go where

9 come back here. It's none of your
10 business who owns it. That's all you
11 gotta tell 'em. None of your fuckin'

13 And then if he fuckin' wants his...if he
14 is a cop, then he's gonna whip his badge
15 out and say I want to see the license.
16 If he ain't a copper, let 'em go where
17 the fuck he's suppose to go, wherever
18 that...Nah, there's no way in my mind
19 I'm, I'm, I'm a hundred and one percent
20 sure that Mike would send some guy here
21 fuckin' with you.

23 CROSS Oh, I (UI).
24
25 WEMETTE I don't think, I don't think...
26
27 SCHWEIHS 'Cause if it ever comes back that it is
28 one of Mike's guys, Mike's got a serious
29 problem with us.
30
31 CROSS Ya know (UI).
32
33 SCHWEIHS ...mean...
34
35 CROSS (UI).
36
37 SCHWEIHS He was told...he cannot say that he
38 don't know that this place is spoken
39 for. Do you understand?
40
41 WEMETTE Could it be one of the people I deal
42 with on the west coast...
43
44 SCHWEIHS Ah, they would never come in the (UI).
45
46 CROSS Probably some jagoff from next door,
47 Red.
48

1 SCHWEIHS (UI).
2
3 WEMETTE It's gotta be
4
5 SCHWEIHS (UI) never come in here from California.
6
7 WEMETTE It's gotta be the guy (UI).
8
9 SCHWEIHS Let me tell you something, no one from
10 any out of state would come in this, in
11 Chicago's backyard and fuck with
12 anything.
13
14 WEMETTE Without talking to somebody first.
15
16 SCHWEIHS Why sure, they'd get their ass knocked
17 off, Red. They know that. Chicago's
18 got the worse reputation in the United
19 States.
20
21 WEMETTE I know.
22
23 SCHWEIHS Them fuckin' New Yorkers don't want to
24 come here and fuck around. They know
25 better.
26

3 WEMETTE Got something.
4
5 SCHWEIHS That's how the fuck.
6
7 WEMETTE Due on the 15th.
8
9 SCHWEIHS I paid it, I paid it already, Red. I
10 paid it for ya. I went to my kick for
11 it 'cause ya know, they want to keep the
12 fuckin' books straight and everythings
13 gotta be straightened out by the 15th of
14 the month. So I really didn't get a
15 chance to get down there until the,
16 round the 17th or 18th. So I just went
17 in, ya know, when I seen 'em. I said
18 here I picked up the fucking money and
19 the guys paid, I went into my pocket
20 for...

27
28 WEMETTE Okay.
29
30 SCHWEIHS Now this mother fucker comes back ya
31 know just eye 'em up a little bit, ya
32 know, Lenny.
33
34 CROSS Yeah.
35
36 SCHWEIHS Make sure you don't walk out in the
37 street and talk to him.
38
39 WEMETTE Oh, no, stay on the property.
40
41 SCHWEIHS Make sure you're on your property 'cause
42 make sure you got a stick on ya, and
43 you're on your fuckin' property.
44
45 CROSS No problem.
46
47 SCHWEIHS Don't let him see the stick.
48

1 CROSS I won't.
2
3 SCHWEIHS Just be real nice, ya know. Like you
4 got it in the fuckin' newspaper or
5 something. Just take a piece of
6 newspaper, fold it...
7
8 CROSS (UI).
9
10 WEMETTE He wears, he wears his shirt out like...
11
12 SCHWEIHS Okay. Just tell him listen, it's none
13 of your business who owns this business.
14 You understand what I'm telling ya.
15 Don't come back here, and go where the
16 fuck you want to go with it. Bring it
17 where you want to bring it. Okay,
18 buddy? Don't come back. He's liable to
19 say well did somebody tell you to give
20 me...he says you just hear what I said.
21 Just stay the fuck out of here. It's
22 none of your business who owns this
23 business.
24
25 WEMETTE It can't be California.
26
27 SCHWEIHS I don't give a fuck who it is.
28
29 WEMETTE Okay.
30
31 SCHWEIHS They cannot win the fuckin' battle, Red.
32 I'll put it in writing for you and
33 Lenny.
34
35 WEMETTE (LAUGHS)
36
37 SCHWEIHS You want me to put it in writing for ya?
38
39 WEMETTE No.
40
41 SCHWEIHS This fuckin' joint has been declared for
42 years. There is no one has the right to
43 come in and fuck in our domain. I don't
44 give a fuck if it - who the fuck it is.
45 If it's Al Capone's brother and he comes
46 back reincarnated, okay. This is a
47 declared fuckin' joint, and no one has

1 the right to come and fuck with you,
2 Okay!
3
4 WEMETTE Mike never liked me here.
5
6 SCHWEIHS I don't give a fuck, two fucks about
7 Mike! Mike has nothing to do with this
8 joint. Mike fucks with you, he's in a
9 work of fuckin' trouble with me, Red.
10 Serious fuckin' trouble that he will not
11 overcome, and win no fuckin' battles
12 with me. This is a declared fuckin'
13 joint. He has no business fuckin' with
14 it, and he cannot ever come back and
15 tell us he didn't know. Okay, that's
16 where he's fucked. Lumbo laid it real
17 fuckin' clear to 'em. Don't fuck with
18 ya. Stay away from here and he never
19 come around after that did he? So what
20 does he think, times have changed
21 because Lumbo's sitting in the fuckin'
22 joint? He knows how things work. If
23 the guy dies somebody takes his place.

41
42 WEMETTE Rat holin'?
43
44 SCHWEIHS That's possible. And if they fuckin',
45 and if she', if he does have something
46 to do with the joint next door, were you
47 here bef...wait, you were here before
48 the joint next door.

22

24 better. You know what I mean? He knows
25 what belongs to who, around this fucking
26 city.
27
28 WEMETTE This guy's alone...our other guy.
29
30 SCHWEIHS Yeah, well that's what we heard as of
31 right now. That's what we're working
32 on. That's what we're working on.
33 That's what we're working on.
34
35 WEMETTE So what's gonna happen if...
36
37 SCHWEIHS We'll see.
38
39 WEMETTE When it's done.
40
41 SCHWEIHS We'll see. Don't worry about it. We'll
42 see.
43
44 WEMETTE What we talked about before.
45

7

34
35 SCHWEIHS No. That would be like me going and
36 fuckin' armin' Mike. I know who his
37 fuckin', I know where he's coming from.
38 I know who his boss is. It'd be like
39 me going in there and armin' his fuckin'
40 joint. The guy's gonna tell me what the
41 fuck's wrong with you Frank, ya know,
42 this guy's with me. Okay. This Mike

44 joint. There's no fuckin' way he could
45 ever come near here.
46
47 WEMETTE Well somebody is botherin' me.
48

1 SCHWEIHS Well it's gotta be this prick next door
2 that sent some flunkie mother fucker
3 over trying to give you the impression
4 he's a tough guy.
5
6 CROSS Yeah, well.
7
8 SCHWEIHS It can't be no one in our fuckin' world,
9 in my world. Can't it, can't, it
10 positively cannot be Red.
11
12 CROSS Well.
13
14 SCHWEIHS It's a declared fuckin' joint. It's off
15 limits to anybody in my world. That
16 same way their joints are off limit to
17 me. You understand why I'm trying to
18 tell ya?
19
20 WEMETTE Yeah.
21
22 CROSS Well whoever he is...
23
24 SCHWEIHS And if this kid, the jagoff works for
25 Mike, he's gotta go in and fuckin' get
26 permission. He's gotta declare where
27 he's going to Mike, and who he's trying
28 to arm. And Mike's gotta tell 'em right
29 up front there is no way you're gonna
30 arm that fuckin' joint. It's spoken
31 for. Do you understand? And if Mike
32 didn't do that and this guy is with 'em,
33 I hope this prick is with 'em. I really
34 do hope he's with this Mike. Okay.
35 'Cause he knows better. I don't say the
36 jagoff he sent here, but he can't come
37 here without somebody saying. No one is
38 gonna go and arm this fuckin' joint next
39 door unless someone sends 'em there. I
40 don't know who owns this joint, and
41 maybe they don't want me to know
42 something. So when this guy comes back
43 you flush him the way I told you, Lenny.
44 Tell 'em none of your business who owns
45 the joint. Stay the fuck out of here
46 and go where you want with it. Bring it
47 wherever you want to bring it, buddy,

1 but don't come back. Let's see who he
2 wants to run to.
3
4 WEMETTE So if I come on strong.
5
6 SCHWEIHS If he's a copper, that's a different
7 story. Then he's gonna get fuckin'
8 belligerent and say fuck you. Here's my
9 badge, now I want to see, fine there's
10 the license on the wall.
11
12 WEMETTE I don't have to worry about (UI),
13 there's no copper.
14
15 SCHWEIHS Right.
16
17 WEMETTE We're clean.
18
19 SCHWEIHS Nah. That's what I'm trying to say.
20 But if it's a wiseguy, let's see who he
21 runs back to and say, hey, they told me
22 to fuckin' stick my shove, shove my head
23 up my ass. Told me not to come back.
24 He's gotta go somewhere with it if he's
25 with somebody, don't he?
26
27 CROSS Yep.
28
29 SCHWEIHS Then we'll find out who the fuck these
30 mother fuckers are that are going around
31 armin' joints.
32
33 WEMETTE So I don't have to talk to 'em like a
34 lawyer, like...
35
36 SCHWEIHS You don't have to be nice to 'em. No,
37 just don't, God, don't say listen, I'll
38 shoot you or anything.
39
40 WEMETTE No, no, no, no.
41
42 SCHWEIHS Just tell 'em listen, it's none of your
43 fuckin'...
44
45 WEMETTE But it don't hurt to say get the fuck
46 out of here jagoff.
47

1 SCHWEIHS Nah, don't tell 'em that. Just say,
2 listen, it's none of your business who
3 owns the joint. Don't' come back here.
4 Go the fuck where you want to go with
5 it. Bring it wherever you want to bring
6 it, but don't come back.
7
8 CROSS Make it quick, short and simple.
9
10 SCHWEIHS Huh?
11
12 WEMETTE Quick, short.
13
14 CROSS Quick, short and simple, I said.
15
16 SCHWEIHS In other words, if he's a wiseguy he'll
17 get the message when you tell 'em, bring
18 it where you want to bring it, but don't
19 come back here. Then he'll know he's in
20 trouble. He's gotta go somewhere with
21 it. You understand? That's the only
22 way you can handle these mothers. We
23 got more jagoffs running around and we
24 don't even know who the fuck they are.
25 And half of 'em are undercover coppers
26 going and pressing people that they got
27 something going for 'em. Waiting for
28 some dizzy bastard to jump up and say,
29 hey you mother fucker don't come in my
30 joint, this is an Outfit joint. I'm
31 syndicate. I'm, I'm protected by the
32 Outfit. Now these pricks got a wire on
33 'em You understand? Next thing you do,
34 you get hit with a federal subpoena,
35 Federal Grand Jury, who are you paying
36 to, who's affiliated with, you
37 understand Red? With these fuck, mother
38 fuckers are doing, that's why you got to
39 word yourself carefully when this guy
40 comes back. Don't threaten. Just tell
41 'em in a nice way. It's one of your
42 business. You got the right to tell
43 anybody it's none of their business. If
44 you didn't know me and I come here,
45 what's wrong with Lenny saying to me,
46 it's none of your business who owns this
47 place. Don't come back here. Bring it
48 where you want. Go where you want with

1 it, that's all. What is he, if he's
2 wired up, what the fuck are you telling
3 'em. Nothing. Right.
