3  
4 James How's the drywall guy doin'?  
5  
6 Michael He's alright. He's okay.  
7  
8 James Still ain't heard nothin'?  
9  
10 Michael Few things. He's around. He's there now.  
11  
12 James Oh, okay.  
13  
14 Michael But, uh, you know, uh...  
15  
16 James Put your hand over your mouth.  
17  
18 Michael The broad, the broad from Cicero, you know  
19 who her lawyer was?  
20  
21 James Yeah.  
22  
23 Michael The kid, the guy with Marc.  
24  
25 James Mmm hmm.  
26  
27 Michael G guy?  
28  
29 James Mmm hmm.  
30  
31 Michael He got a hold of, uh, you know the two  
32 brothers from, uh, where the, where the bad  
33 knee was? You know, the two brothers, the  
34 union guy that was with, uh, with that union,  
35 with the brother? Got a hold of the younger  
36 brother, the guy that his kid got fucked up  
37 that time?  
38  
39 James The two brothers, the guy with the bad knee?  
40

1 Michael Yeah, he lived by me.  
2  
3 James Oh, yeah, yeah, yeah, yeah, yeah.  
4  
5 Michael The kid, the guy whose kid got...  
6  
7 James Yeah, yeah.  
8  
9 Michael He got a hold of him last week and he went  
10 and seen him.  
11  
12 James Uh huh.  
13  
14 Michael Uh, that thing is all in that, in that  
15 Pagliacci and the north side direction.  
16 Nothin' over here.  
17  
18 James Nothin'. Okay.  
19  
20 Michael That came from there.  
21  
22 James ...okay. Remember I told you that?  
23  
24 (NON-PERTINENT CONVERSATION)

3 James How you been? Everything been okay with you?

4  
5 Michael So far, yeah.

6  
7 James Trucker and everybody else?

8  
9 Michael Yeah, they're not bothering 'em at all.

10  
11 James That's what I'm tellin' ya. What did, uh,  
12 the drywall guy say? Anything at all, I  
13 mean, did he hear anything or...

14  
15 Michael No, nothing. He's here now, I know he is.

16  
17 James Uh huh.

18  
19 Michael He's givin' up some coppers or somethin' he  
20 told me. 'Cause he's...Did he get into  
21 business with someone? Some coppers or  
22 something?

24 (NON-PERTINENT CONVERSATION)

2  
3 James So what's goin' on, buddy? Anything special?  
4 Anything good?  
5  
6 Michael Nah, not really.  
7  
8 James As long as you guys are okay.  
9  
10 Michael Everything is quiet. Everything is...  
11  
12 James Did the Durango kid come back from Arizona  
13 yet?  
14  
15 Michael This guy (puts his hands in front of his  
16 stomach)?  
17  
18 James No. Fau Fau.  
19  
20 Michael Oh, yeah. Yeah, he came back. He's home.  
21  
22 (Pause)  
23  
24 Michael He went to, he went out west that Friday  
25 night. Met Nick.  
26  
27 James Uh huh.  
28  
29 Michael And he went with that, uh, kid, John. You  
30 know, Joe's kid?  
31  
32 James Yeah.  
33  
34 Michael Where that, uh, where them guys used to be  
35 way out west before, remember? At, uh,  
36 Joe's, Joe, uh, Rockford. You know.  
37  
38 James Oh, yeah, yeah, yeah, yeah. So what'd he go  
39 out there for?  
40  
41 Michael Nosin' around. Thinks he's gonna find a  
42 spot, find somebody, one of them old timers  
43 out there, or something. You know.  
44  
45 James What for? He don't even know. Before I left  
46 I met all them new guys. I told 'em. (UI)  
47 all the new guys. The old guy stepped down,  
48 make way for all the new guys (UI). (UI) for

1 two years. He don't know what the fuck's  
2 goin' on. He should stay home and mind his  
3 own fuckin' business. Matter of fact, one  
4 time I met him with this kid's old man.  
5  
6 Michael Oh, yeah?  
7  
8 James Yeah. That's how long ago it was. You see  
9 what I mean, Mick? Instead of askin' about  
10 it, 'cause he's got nothin' to do. Okay.  
11 Matter of fact, one of the guys, the sutto,  
12 used to be around these guys. From that  
13 neighborhood, the two brothers from  
14 Bridgeport.  
15  
16 Michael Mmm.  
17  
18 James (UI) was part of them guys.  
19  
20 Michael This here (raises two fingers).  
21  
22 James Yeah. He used to be with these guys (making  
23 a sweeping motion back and forth with his  
24 hand).  
25  
26 Michael Mmm.  
27  
28 James He had the stuff with them. We made the  
29 introduction years ago. Because the guy  
30 (UI) like this (puts his two fore  
31 fingers together). The guy with the bad  
32 knee came to me and he says I'll get a hold  
33 of the guy for you. You know. Go out  
34 there and straighten it out. (UI)  
35 business (UI). You know. (UI) We met  
36 'em all. You know. There's one, one,  
37 two, maybe three guys. Okay? Not that  
38 they've got a few others but I mean all  
39 the ones that are supposed to be where  
40 they are.  
41  
42 Michael Mmm hmm.  
43  
44 James You know. Tell him, (UI). Does, uh, the  
45 Trucker know he did that?  
46  
47 Michael I don't know.

1 (NON-PERTINENT CONVERSATION)  
2  
3 James You think Mick, you uh, we'd, where he'd be  
4 (motions with fist to his chest).  
5  
6 Michael As far as, uh...  
7  
8 James Polizie.  
9  
10 Michael I don't know. Trying to...I'll find out.  
11  
12 James The guy giving it to you?  
13  
14 Michael Yeah, the guy, his babysitter.  
15  
16 James Oh, yeah?  
17  
18 Michael Babysitter guy, same guy.  
19  
20 James Same guy that was at the other place with  
21 him?  
22  
23 Michael (Nods affirmatively) Same guy that took him  
24 the first time. (Pause) You know the guy?  
25  
26 James Are you doing anything? Are you able to  
27 do...?  
28  
29 Michael Uh, he won't, uh. The guy told...You know a  
30 guy by the name of, was a copper, Derango,  
31 Tony Derango?  
32  
33 James I grew up with him.  
34  
35 Michael Huh?  
36  
37 James I grew up with him. He was, uh, in our old  
38 neighborhood, that district.  
39  
40 Michael Marquette, the Marquette Ten.  
41  
42 James Mmm hmm.  
43  
44 Michael 'Cause he's friends with this guy (nods his  
45 head to the left). His father was close to  
46 that guy.  
47  
48 James This guy (touches his nose), right?

1 Michael (Shakes his head no) Derango. And, uh,  
2 another guy by the name of Guide. Guide was  
3 close to this guy (motions to his nose).  
4  
5 James Okay.  
6  
7 Michael They both were, really both of them. They  
8 both knew him from Marion Camp.  
9  
10 James Okay.  
11  
12 (Pause)  
13  
14 Michael They're, uh...This kid's father was with  
15 them.  
16  
17 James Mmm hmm.  
18  
19 Michael On that beef and everything. He went down  
20 with them. He died though.  
21  
22 James Oh, did he?  
23  
24 Michael The kid's father died. So they like, you  
25 know, the kid comes down. You know what I  
26 mean?  
27  
28 James Yeah.  
29  
30 Michael They were close to the father.  
31  
(NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)  
2  
3 Michael Yeah, I told him, see if the guy goes and  
4 sees, uh, or if she goes and sees him. You  
5 know.  
6  
7 James Yeah.  
8  
9 Michael This way...  
10  
11 James Then you know.  
12  
13 Michael ...then we know. That's all I wanna know.  
14  
15 James Just keep doing the same thing. Something's  
16 gotta, sooner or later gotta find out  
17 something. You know what I mean?  
18  
19 Michael They talked...It came back too through that,  
20 uh, guy that, uh, lawyer. The one that seen  
21 the guy with the. You know. The guy from  
22 that neighborhood.  
23  
24 James Mmm hmm.  
25  
26 Michael This, this here direction (touches his nose).  
27 They thought they really had somethin'. Now  
28 they're kinda not sure of it. This guy  
29 (touches his nose).  
30  
31 James Oh, yeah?  
32  
33 Michael But the other guy, goin full steam ahead for  
34 him.  
35  
36 James The other guy all of a sudden now they're not  
37 so sure, huh?  
38  
39 Michael This guy (motions to nose).  
40  
41 James Uh huh.  
42  
(NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)

2  
3 Michael Oh, I know what I wanted to tell you. Chops  
4 got a subpoena for the grand jury.

5  
6 James Okay.

7  
8 Michael Eh, they pushed it up two weeks. It was  
9 supposed to be not last week, but the week  
10 before and they called Bobby DeMeo and Bobby  
11 DeMeo may use Alex. I mean, it'll probably  
12 be like either this week or the following  
13 week.

14 (NON-PERTINENT CONVERSATION)

3 James Well, that's good to know. We'll see what  
4 they, questions they got for him. Unless of  
5 course he's gonna take this (holds up five  
6 fingers). Either way we'll know.

7  
8 Michael Well...

9  
10 James Well, we might find out some...

11  
12 Michael Don't they gotta give you the list before you  
13 go in?

14  
15 James Not when you first go in. I think that's if  
16 you, if you get into it with 'em. You know  
17 what I mean? I think.

18  
19 Michael I, I don't know. That other guy in that  
20 direction, east out there. You know that  
21 Pagliacci. Something there for whatever  
22 reason. The way it looks.

23  
24 James Yeah?

25 (NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)

3 James How 'bout that, uh, this guy's (pointing to  
4 his knee) old neighborhood? What's goin' on  
5 around there?

6

7 Michael We got stuff goin' there. Tryin' to get some  
8 of those Chinese spots with poker machines  
9 and all that and, uh, they got a game, it's  
10 in Chinese. It's called, uh, Pau Gau or Pi  
11 Gau or somethin' like that.

12

13 James It's the paid game they call it, Pi Kow.

14

15 Michael Yeah, so they got it on the machine, now.

16

17 James Oh, yeah.

18

19 Michael So, those, I got him...I made him a contact  
20 where they get the boards from to make the  
21 ones they got, you know, over to these.

22

23 James Yeah.

24

25 Michael So try 'em out and see how they work.

26

27 James Sure, hell, yeah.

28

(NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)

2  
3 James Oh, I know what I wanted to tell you. See  
4 the guy you're with? The Captain?

5  
6 Michael Mmm hmm.

7  
8 James You know his nephew, you know what they own,  
9 his nephew and his brother-in-law? You know  
10 the girl from the farm, her name?

11  
12 Michael Yeah. Yeah, right.

13  
14 James Okay, this guy when he was home was doing  
15 some work out there. They winged him real  
16 good some years back, the brothers.

17 (NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)  
2  
3 James The guy was paying like this (motions with  
4 two fingers), plus he, you know, what he,  
5 they paid him in the beginning. So, you give  
6 me this (motions with his fingers) a month.  
7 So, the guy says okay. So, he was gettin'  
8 that a month. Now when he come in, he knows  
9 when he saw the guy and this guy's nephew, he  
10 said look, you know where I'm goin', blah,

13  
14 Michael Fifty?  
15  
16 James (Shakes his head, no.)  
17  
18 Michael Five.  
19  
20 James (Shakes his head yes.) Five hundred.  
21  
22 Michael A month?  
23  
24 James Yeah. He says and I when I come back from  
25 where I'm goin', you don't have to, you don't  
26 owe nothin'. And he was takin' that a month,  
27 you know the kid that's, you remember that  
28 kid that's in the camp (UI) with the name  
29 like the store in the old neighborhood.  
30  
31 Michael Yeah, yeah, yeah, yeah, yeah, yeah.  
32  
33 James (UI) This guy was pickin' it up. This kid.  
34  
35 (NON-PERTINENT CONVERSATION)

3 Michael Why doesn't he have to now?

4  
5 James That's what he wants to ask. Who gave  
6 him...who told him he didn't have to pay.

7  
8 Michael That's (UI).

9  
10 James See, what it is, I don't want you gettin'  
11 involved. Your name with him and, uh, tell  
12 the Trucker...

13  
14 Michael Yeah, that's what I was gonna do.

15  
16 James To go the other way. You follow me? Who  
17 told him? It must of been Flapjacks or  
18 somethin'. (UI)

19  
20 Michael Mmm hmm.

21  
22 James You know what I mean?

23  
24 (NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)

2  
3 James Who's gettin' that stuff that, uh, uh...  
4 Remember the guy that used to live next door  
5 to our nephew? Number two?

6  
7 Michael Who, uh...

8  
9 James This guy (puts his hands out in front of his  
10 stomach) used to get it, right?

11  
12 Michael Yeah he still gets it.

13  
14 James Does he turn it in? Does he...

15  
16 Michael We, we use that. He gets, uh...Wait a  
17 minute. He collects that, he collects from a  
18 few guys by where he used to be, in that area  
19 there. Then I gotta give him, uh, 14. No he  
20 collects 26 and I give him 14. That makes  
21 40. He says two a piece up south to the two  
22 guys.

23  
24 James Mmm hmm.

25  
26 Michael That's how it is.

27  
28 (NON-PERTINENT CONVERSATION)

1 (NON-PERTINENT CONVERSATION)  
2  
3 James Did, uh the Trucker straighten out with that  
4 kid from, uh, uh, Captain's neighborhood with  
5 this here (motions as if holding cash) for  
6 this here stuff (motions as if brushing  
7 something away).  
8  
9 Michael Yeah...  
10  
11 James Understand he had a good, uh...  
12  
13 Michael ... (UI).  
14  
15 James Uh huh.  
16  
17 Michael Wound up with, uh, he took fifty off the nut.  
18 Fifteen or twenty there is up in the air for  
19 basketball.  
20  
21 James Uh huh.  
22  
23 Michael Wound up with, he's got a square that goes  
24 into the thing...If it hits for the...They  
25 got a 2000 square pool for the what d'ya call  
26 it.  
27  
28 James Well, they always did, them guys.  
29  
30 Michael For the basketball.  
31  
32 James Yeah.  
33  
34 Michael NBA or...  
35  
36 James Right, for the, uh, sweet 16.  
37  
38 (Pause)  
39  
40 James But he straightened out with him, huh?  
41  
42 Michael Mmm hmm.  
43  
44 James Anybody else, uh...For the season? Anybody  
45 else come around?  
46  
47 Michael Well, we got a couple guys that pay the tax,  
48 small (UI). We got that kid that Fau Fau

1 had. You know. Oh, and, uh, what's his name,  
2 Mario.  
3  
4 James Yeah.  
5  
6 Michael He come in pretty good this year.  
7  
8 James Did he? He ought to, that cocksucker, he  
9 ruined me. He's the motherfucker that had  
10 them guys that cost me all that money.  
11 (Pause) Then the last gift I got was I got  
12 indicted.  
13  
14 (Pause)  
15  
16 James That's good. Better get our end.  
17  
18 (NON-PERTINENT CONVERSATION)
