## **COUNT ONE**

The SPECIAL SEPTEMBER 2014 GRAND JURY charges:

From on or about July 21, 2014, until on or about September 22, 2014, at Chicago, in the Northern District of Illinois, Eastern Division, and elsewhere,

JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, not being a licensed dealer, within the meaning of Chapter 44, Title 18, United States Code, did willfully engage in the business of dealing in firearms;

#### COUNT TWO

### The SPECIAL SEPTEMBER 2014 GRAND JURY further charges:

On or about July 22, 2014, at Chicago, in the Northern District of Illinois, Eastern Division,

### JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Harrington and Richardson, .22 caliber revolver, bearing serial number 541564; a Taurus, .38 caliber revolver, bearing serial number 739335; and a Mossberg, model 500A, 12 gauge pump shotgun, bearing serial number L043544, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

#### **COUNT THREE**

### The SPECIAL SEPTEMBER 2014 GRAND JURY further charges:

On or about July 30, 2014, at Chicago, in the Northern District of Illinois, Eastern Division,

### JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a F.B. Radon VIS pistol, model 35, bearing serial number S2007; a Taurus pistol, model PT101AF, .40 caliber, bearing serial number SOB44441; and an Intratec pistol, model TECDC9, 9 mm caliber, with an obliterated serial number, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

### COUNT FOUR

## The SPECIAL SEPTEMBER 2014 GRAND JURY further charges:

On or about August 20, 2014, at Chicago, in the Northern District of Illinois, Eastern Division,

JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Ruger pistol, model P97DC, .45 caliber, with an obliterated serial number, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

### COUNT FIVE

### The SPECIAL SEPTEMBER 2014 GRAND JURY further charges:

On or about August 25, 2014, at Chicago, in the Northern District of Illinois, Eastern Division,

JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Browning pistol, 9 mm caliber, bearing serial number 69C9283; and a New England Firearms shotgun, model Pardner, 20 gauge caliber, bearing serial number NM318106, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

### COUNT SIX

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Ruger pistol, model P95, 9 mm caliber, bearing serial number 318-33683; and a Romarm/Cugir rifle, model GP WASR 10/63, 7.62 caliber, bearing serial number AR273072, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Velocity Firearms pistol, model VMAC 45, .45 caliber, bearing serial number P12905; a Hi-Point pistol, model C9, 9 mm caliber, bearing serial number P1812679; a Hi-Point pistol, model C9, 9 mm caliber, bearing serial number P1520281; a Smith & Wesson pistol, model SD40VE, .40 caliber, bearing serial number HFN3008; an AA Arms Inc. pistol, model AP9, 9 mm caliber, bearing serial number 046610; and a Charter Arms revolver, model Undercover, .38 caliber, bearing serial number 181172, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

### COUNT EIGHT

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Glock pistol, model 17, 9mm caliber, bearing serial number AAEU668, an Interarms pistol, unknown model and caliber, bearing serial number 1123611; and a Smith & Wesson revolver, unknown model, .38 caliber, with an obliterated serial number, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;

### **COUNT NINE**

## The SPECIAL SEPTEMBER 2014 GRAND JURY further charges:

On or about September 22, 2014, at Chicago, in the Northern District of Illinois, Eastern Division,

JIMMY WRIGHT, also known as "Lil Man,"

defendant herein, previously having been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting interstate commerce, a firearm, namely, a Rexio revolver, model RJ38, .38 caliber, bearing serial number 105365; and a Norinco rifle, model SKS, 7.62 caliber, bearing serial number 22001836, which firearm had traveled in interstate commerce prior to the defendant's possession of the firearm;
