Featured Presenter:

Lt. Col. David Grossman

Col. Grossman is a former West Point psychology professor, Professor of Military Science, and an Army Ranger who has combined his experiences to become the founder of a new field of scientific endeavor, which has been termed "killology." In this new field Col. Grossman has made revolutionary new contributions to our understanding of killing in war, the psychological costs of war, the root causes of the current "virus" of violent crime that is raging around the world, and the process of healing the victims of violence, in war and peace.



Col. Grossman is an Airborne Ranger infantry officer, with a total of over 23 years experience in leading U.S. soldiers worldwide. He retired from the Army in February 1998 and has devoted himself to teaching, writing, speaking, and research. Today he is the director of the Killology Research Group, and in the wake of the 9/11 terrorist attacks he is on the road almost 300 days a year, training elite military and law enforcement organizations worldwide about the reality of combat.

Important Information

This training is *free* to all state, county, and local law enforcement agencies. **Two nights** lodging (9/3 & 9/4) will be paid for state, county, or local law enforcement only (employees of the federal government or private corporations are not eligible). For lodging to be covered, the eligible attendees must live more than 50 miles from the conference location. Attendees staying more than the designated 2 nights are responsible for the extra night's expense. Those who register and *do not* attend will be responsible for the lodging expense if not cancelled by the required deadlines. Mileage and per diem will not be covered and are the responsibility of the individual or agency. **All hotel rooms will be double occupancy with ONLY conference attendees.**

Lodging will be at the Sheraton Hotel at Keystone Crossing, 8787 Keystone Crossing, Indianapolis, IN 46240. Once participants arrive at the hotel they will be required to provide a credit card to cover any incidentals. The credit card (no debit cards, please) will not be charged for the room fee *if* the attendee meets the eligibility requirements. **Lodging requests must be received by August 22, 2014 (The US Attorney's Office will make the reservations and/or cancellations).
