Coleman: Good, how are you?


Petters: This seven hundred billion dollar bailout, how come we're not in that?

Um, you know, I just got done talking with John Koneck, who is a really, a good friend of ours. And John said, I just want to make sure you're okay and I just want to make sure. And I said I'm not okay. None of us are okay.
- Coleman: Right.
- I said we got problems, John, and I'm just kinda here Petters: to tell you that the problems are, you know, big, but I I said I think that there are ways we can work out of them. And he said, well I just wanna make sure that, you know, you and Deanna and, look, I don't go out there saying stuff to people. Bob, Bob is the one who blew up at Stewart Cohen and people about me. Telling, telling people all the time he blew up at Mike Catain, he blew up at people and telling them that, you know, he had stuff over me and over you. I know you don't believe that, but he that's what he did. He said, you know, he told Stewart Cohen who was at my house yesterday, didn't even respond, but he goes Bob White's still with you? - Coleman: I know. You won't. He'll just.
- Petters: He'll just kind of go crazy.
- Coleman: Right.
- Petters: But remember how he went crazy on, his son went crazy on us?
- Coleman: Oh yeah. When we wouldn't give him money.
- Petters: Right. So, so, so just, just between you and me. It's not like everybody didn't know what was going on. I've had my share of hits. I'm trying as hard as I can to figure out how to get out of this. I may not be able to get us out of it, but I think I can. And I don't think you know where the purchase orders were made or something like that when I ask questions. I just, it's like, I don't think we all can think clearly anymore, including me.
- Coleman: Mm-hm.
- Petters: You know? And I think when people ask us questions, we don't know what to say. And I border on, you know, more of a salesman telling more story and I shouldn't. You, Bob borders on never telling anybody a fucking thing about anything, he just gets mad when he can't get his way, and you don't know what to say, and you're in the middle, you know? And the truth is, um, no matter how anything happened yesterday, it doesn't matter. And what I said a year or two, three years ago, it just as aggravated as you get about me telling them they'll get money. I wish we all would have taken two or three days and sat down and figured out how just not to tell them we're giving them any more purchase orders. Because that'll be our death.

- Petters: If there is one. And I mean, we got all these wonderful companies, and they're losing money and some are making money and we got plans for them. I just blew off my flight at 11 o'clock. (UI). I've got to get Ted Deikel his money and I've got to get Sabeses their money tomorrow, and the rest of the hedge funds and everything else we can make our way through. I got a plan. I can't think anymore.
- Coleman: Mm-hm.
- Petters: Ted Deikel sent me the most fucking awful weepy letter that we promised him six times and today has to be the day and it came out of his kid's trust account, and that he's going to get, you know, I have all of his help. If you read the book that I have on the Sabeses, you will know how much trouble Jon Sabes is in.

Coleman: Why is he in trouble?

- Petters: Oh, he registered this Life Settlement Insurance Company. Guess where he did his, they tried to get approved in Minnesota. I have a book that's in my car, Have Joe give it to you, if you want to read about the Sabeses. Jon, they can't get approved in Minnesota because they think they're part of the mob.
- Coleman: Which Bob White's always told me they were part of the mob, but I'm not, I don't know that, but.
- Petters: Well, Bob, I mean, GE Capital told us there was, we were dealing with less than reputable people. I didn't know who they meant. But when you read through this book,
- Coleman: Probably Frank and Bob Sabes.
- Petters: I, I honestly never knew how bad Bob was. I didn't, I told, you know me, we'd go to breakfast with my, I know what a mean fucker he was to you a couple of times and that really made me mad, but I didn't know. Thought he just had a temper. So, I listened to what Bob said, you know. Bob thinks I don't listen to him ever, I do. Bob is very, very smart. Bob is also very dangerous, um.

Coleman: I believe that.

Petters: I mean, Bob's the kind that like with the time bomb

- Petters: Who Sabes?
- Coleman: Sabeses.
- Petters: I don't know. Mike Hatch has a 3-ring binder like this. But anyway, the kid filed for insurance, registered insurance in Colorado, used my address on my house in Keystone.
- Coleman: He did?
- Petters: Paid a guy up there. They got all this stuff on him. They're ready to blow him sky high. He's got this life, Jon Sabes needs to calm down a little bit. See, but I'm not, I'm gonna get him paid, and then we're gonna, I, I won't do anything. You'll watch his company go like a sky rocket into the sky.
- Coleman: Wow.
- Petters: Um, David Baer went and asked Mike Hatch and Lori Swanson, and they hired this person for the state and they did all the security (UI) to see what they could find out. They have stuff on Janet Sabes. They have stuff on Bob. And all their company has paid to make their name look good in this town and how they were in the mob, and how his father was in the mob and how he had Shieks and all this stuff, and how they paid lobbyists to try to overturn things when they happened. Bad people, bad, bad people. And Bob's right.

Petters: And I didn't, see, see, I, I, when I was going to get money from them, um, he also, see this is where Bob confuses me. If he's known all this and how bad the guy was, I mean, I've heard him say it the last few months, six months or something or nine months but I've never really heard him say much to me ever before. Maybe he said it to you. Whether he did or didn't doesn't matter. He is what he is and I just want to get him paid off. The reason I want to get him paid off is I think he'd kill me.

- Petters: I think. No, I think. No, no I think...
- Coleman: If you had said that six months ago when we owed him 50, 60 million dollars...
- Petters: 150 million.
- Coleman: I would have, I would definitely have said yes, but now that we owe him 17 million, I think he'd be...
- Petters: If I don't pay him.
- Coleman: I think he'd be very, very upset and I think he would do everything to lock you up. But um I don't think...
- Petters: No, I don't think he wants to lock me up.
- Coleman: You think he would still go after you? Even for 17 million, when they've made...
- Petters: No, Jon would.
- Coleman: How many millions?
- Petters: Jon's, Jon's the next generation of the mob, not Bob. Bob is telling Jon to back off on this. Jon keeps going forward. Jon hates me. Jon is jealous of me. Jon's their rep, family reputation, he wants it to be like ours. See what they hate about me, now I know, is that people like me so much. And that we have such a good reputation and that after all the things that have happened. Notice they didn't support Jon's deal this year.

Coleman: No.

Petters: They talk about how they sprinkle their money around to various organizations trying to get support. They talk about the University of Minnesota saying we will not take a million dollar donation from you guys and we're returning the money.

Coleman: Really?

Petters: Yeah. But it's, there's a lot of stuff. The, there, there, you read, I got sick reading it last night

It's gonna kill you. It's killing me what I'm doing and it's killing Bob, okay. And what it has to be is, we can't live in a world of shit anymore. We have to come up with a plausible reason and get the fuck out of this. Cuz I, this is where it differs between you and I. See if Bob could get away with it, he wouldn't mind. I can't stand it. I can't stand lying to people everyday. I mean that. I'm not saying that cuz I'm such a good soul.

Coleman: I know, Tom, I can't.

- Petters: I just, I can't stand the fucking lies. Like Nis and those goddamned lies. And I mean I love Nis and, and it's all these people, I just want to get them out and see and the thing that bothers me about Bob, it's like with those letters, that's a stone cold lie or he has a bad memory, it's a stone cold...
- Coleman: See, I don't, I wasn't there, and that's. I don't know why he got so upset about it. But I mean, it's just...
- Petters: I know, I know, and I don't care. See, I don't even want to tell him. I don't even want to say that anymore. You know what it is? I'm extra sensitive to, as I said to you one day when we were on the phone, you know, I, we all are. We all have our. We all are scared, so. I know that. Listen, if I don't pay

- Coleman: Mm-hm. So don't mention that to Bob. Because I know Bob is afraid of Sabeses. So don't have this conversation with Bob because he would really...
- Petters: They're never gonna go after Bob. Bob's a gnat on their ass. They don't care about Bob. They, they love to. See Jon Sabes thinks he like the, the um, replacement to Bob now. But he's not gotten his, his stripes, you know what I mean. He's trying to earn his stripes. In his business, I mean Hatch is...
- Coleman: Jon is just a wanna-be. You can tell by being around him.
- Petters: Hatch is gonna blow up his business and Lori Swanson and seriously they, they applied for insurance in Colorado, tried to transfer it to the Department of Texas, called Colorado, Colorado, they got turned down in Minnesota. Their whole portfolio in Minnesota is illegal. They lose everything. All Bob's money that he's invested in, Bob, Bob is gonna go ape shit with Jon.
- Coleman: Wow.
- Petters: And you can read about it. What he did, where he applied, what he did. 321 Elk Circle. Or 31 Elk Circle, that's my log cabin right in Keystone.

- Petters: Where it's reported. With the guy's address, with the address in Minnesota.

- Petters: She said she thinks Bob's a billionaire and she will do exactly what she did to her ex-husband, she took everything, went to court, she spent \$350,000 on the divorce, she tried to get everything out of him she could. Told the guys (UI) and said they have pictures of Bob and her, which is disgusting, screwing in the boat.
- Coleman: Yeah, you don't have to tell me that. That's really gross. Kind of gives me the creeps already.
- Petters: But anyway, look ah I'm sorry about the crying episode.
- Coleman: No, that's...
- Petters: I'm just telling ya, I think about my kids more than anything.
- Coleman: Well, I mean, you need to.
