Former Bank Employee Sentenced to 57 Months in Prison For Thefts Totaling \$496,000 from Wachovia Bank

TRENTON – A former bank employee was sentenced to 57 months in federal prison today for thefts totaling approximately \$496,000 from bank teller drawers and automated teller machines at a Wachovia Bank branch in Ewing, U.S. Attorney Christopher J. Christie announced.

U.S. District Judge Mary L. Cooper also ordered Richard F. Harriott, 30, a.k.a. "Richard Harrison," a Jamaican national who resides in Ewing, to pay \$496,140 in restitution and to serve 5 years of supervised release upon the completion of his prison term. Judge Cooper ordered his immediate detention because Harriott failed to appear for his sentencing previously scheduled for July 25, 2007.

At his plea hearing on March 20, 2007, Harriott admitted that from April 2004 through May 2005, while employed as a teller manager by Wachovia Bank, he misapplied funds from his teller drawer. Harriot admitted that he repeatedly submitted false transaction reports indicating that various bank customers had performed transactions which, in fact, did not occur. He admitted doing so in an attempt to cover up his thefts from his teller drawer. Harriott admitted that as a result of his embezzlement he was fired from his position.

On Jan. 25, 2006, after his employment was terminated and he had been arrested for the embezzlement, Harriot entered the same bank branch after it had closed for business and committed a theft of approximately \$351,000 from two automated teller machines, he admitted.

The defendant was first arrested on Feb. 21, 2006, on a one-count Indictment, which was returned by a grand jury on Feb. 16, in connection with the embezzlement of funds from teller drawers. The defendant was arrested again on April 25 on a separate Indictment, which was returned on April 20, in connection with the ATM thefts. On July 13, 2006, a Superseding Indictment combining the charges in the earlier Indictments was returned by a grand jury.

Harriott pleaded guilty to one count of embezzlement of bank funds for the theft of funds from the teller drawers. He also pleaded guilty to one count of stealing approximately \$351,000 from the ATM machines.

In determining the actual sentence, U.S. District Judge Mary Cooper consulted the advisory U.S. Sentencing Guidelines, which provide appropriate sentencing ranges that take into account the severity and characteristics of the offense, the defendant's criminal history, if any, and other factors. The judge, however, is not bound by those guidelines in determining a sentence. Parole has been abolished in the federal system. Defendants who are given custodial terms must serve nearly all that time.

Christie credited Special Agents of the FBI's West Trenton Resident Agency, under the direction of Special Agent in Charge Weysan Dun, with the investigation.

The government is represented by Assistant U.S. Attorney Peter Katz of the Criminal Division in Trenton.
