INDICTMENT

The Grand Jury charges:

Count 1

On or about the dates set forth below, in Bernalillo County, in the District of New Mexico, the defendant, JORDAN EARL MADISON JR., having been previously convicted of Attempted Molestation of a Child, a felony in violation of A.R.S. §§ 13-1001 and 1410 in Pima County Superior Court of Arizona, Cause No. CR-15028, did knowingly distribute and attempt to distribute visual depictions contained in the computer files described below, using a means and facility of interstate and foreign commerce, and which visual depictions had been mailed and shipped and transported in interstate and foreign commerce, and which contained materials which had been so

mailed and shipped and transported by any means, including by computer, the production of which visual depictions involved the use of a minor engaging in sexually explicit conduct and are of such conduct:

Counts 2 and 3

Count 4

On or about March 18, 2010, in Bernalillo County, in the District of New Mexico,

the defendant, **JORDAN EARL MADISON JR.**, having been previously convicted of Attempted Molestation of a Child, a felony in violation of A.R.S. §§ 13-1001 and 1410 in Pima County Superior Court of Arizona, Cause No. CR-15028, did knowingly possess a matter, to wit: Dell Tower, serial number 9CLNF41, which contained two internal hard drives to include one Seagate 160GB with serial number 4JS1GEVN and one Western Digital 500GB with serial number WCAPW4851165, containing visual depictions that had been shipped and transported in interstate and foreign commerce and which were produced using materials which had been shipped and transported, by any means, including by computer, the production of which visual depictions involved the use of a minor engaging in sexually explicit conduct and are of such conduct.

In violation of 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256.

FORFEITURE ALLEGATIONS

Upon conviction of any offense alleged in this Indictment, Defendant JORDAN EARL MADISON JR. shall forfeit to the United States pursuant to 18 U.S.C. §§ 2252 and 2253:

- (A). A Dell Tower Computer, serial number 9CLNF41, which contained two internal hard drives to include the following:
 - (1) one Seagate 160GB Hard Drive with serial number 4JS1GEVN, and
 - (2) one Western Digital 500GB Hard Drive with serial number WCAPW4851165.
