## AFFIDAVIT IN SUPPORT OF CRIMINAL COMPLAINT

I, David Smith, being duly sworn do hereby depose and swear as follows:

I am employed as a Special Agent with the Drug Enforcement Administration (DEA) currently assigned to the Albuquerque District Office, Albuquerque, New Mexico.

This afficivit is made in support of a criminal complaint being filed against Manuel FUS TES-Careno and Juan Manuel FUENTES-Ontiveros charging them with violating litle 21 USC 841(a)(1), 841(b)(1)(A) to wit: possession with intent to distribute 1000 grams or more of heroin.

On November 17, 2010, the Honorable Robert H. Scott signed a search warrant for 627 82 M. Albuquerque, New Mexico. On November 17, 2010, agents executed the search warrant at 627 82 M. Albuquerque, New Mexico. As a result of the search warrant, agents located two vehicles in the garage. Agents located a white vehicle and a black Jeep Cherokee bearing New Mexico license plate LBC997. Inside the vehicles, agents located and seized approximately 6.45 gross kilograms (approximately 14 pounds) of heroin. Inside the residence agents located a Mexico Passport in the name of Manuel FUETNES-Careno and a wire transfer receipt showing Manuel FUENTES-Careno as the sender.

On November 12, 2010, agents were conducting surveillance at 627 82<sup>nd</sup> SW, Albuquerque, New Mexico. Agents observed Juan Manuel FUENTES-Ontiveros arrive at the residence driving a brown Mercury Sable. A short time later, agents observed Manuel FUENTES-Careno arrive at the residence driving the black Jeep Cherokee with New Mexico license plate LBC997.

On November 15, 2010, an agent observed Juan Manuel FUENTES-Ontiveros driving the black Jeep Cherokee.

On October 28, 2010, agents conducted a trash pull at 627 82<sup>nd</sup> SW, Albuquerque, New Mexico. In the trash, agents located a receipt from Motel 76. The name on the receipt was Juan Manuel F.O. Another area of the receipt listed the names as FUENTES-Ontiveros.

For the reasons set forth above, SA David Smith respectfully requests the court to approve this criminal complaint charging Manuel FUENTES-Careno and Juan Manuel FUENTES-Ontiveros with violation of Title 21 USC 841(a)(1), 841(b)(1)(A), to wit: possession with intent to distribute over 1000 grams of heroin.

This affidavit is submitted for the limited purpose of providing probable cause to support the attached criminal complaint. I have not set forth each and every fact learned during the course of this investigation in the above affidavit. Affiant respectfully requests the approval of this criminal complaint for Manuel FUENTES-Careno and Juan Manuel FUENTES-Ontiveros charging each with violating Title 21 USC 841, to wit: possession with intent to distribute over 1000 grams of heroin.
