Counts 1-10

FORFEITURE ALLEGATION

Upon conviction of one or more of the offenses alleged in Counts 1 through 11 of this Indictment, the defendant **DAVID RIVERA** shall forfeit to the United States pursuant to 31 U.S.C. § 5317(c)(1) or 21 U.S.C. § 853 any property, real or personal, involved in the offense and any property traceable thereto, including but not limited to the following:

MONEY JUDGMENT: A sum of money equal to at least \$1,920,440 United States currency, representing the amount of money derived from or involved in the offenses.

BANK ACCOUNTS: Funds totaling \$520,171.62 seized the following amounts from the following bank accounts on July 1, 2010:

- 1. \$231,950 from Guadalupe Credit Union, account number -3000-0;
- 2. \$6,500 from Guadalupe Credit Union, certificate of deposit account -3000-84;
- 3. \$1,500 from Guadalupe Credit Union, account number -3000-71;
- 4. \$227,500 from Los Alamos National Bank, account number -0320;
- 5. \$50,320.18 from Wells Fargo Bank, account number -3470;
- 6. \$900 from Wells Fargo Bank, account number -3470;
- 7. \$648.50 from Wells Fargo Bank, account number-4183; and
- 8. \$852.94 from Wells Fargo Bank, account number -9879.

<u>SUBSTITUTE ASSETS</u>: If any of the above-described forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third party;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value;
- (e) has been commingled with other property which cannot be divided without difficulty;

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 982(b), to seek forfeiture of any other property of the defendant up to the value of the forfeitable property described above.
