Pierson, am a Special Agent of the 11 1) Federal Bureau of Investigation (FBI), currently assigned to 12 the Albuquerque Division, Gallup Resident Agency. The 13 information set forth is known to me as a result of my own 14 15 investigation or has been communicated to me by other law enforcement officers. 16 17 This affidavit has been made in support of a 18 2) criminal complaint against TONY CURTIS JUNIOR, born in 1973, 19 2.0 for the assault with a dangerous weapon resulting in the 21 serious bodily injury of RYAN JOHN, born in 1988, in violation of Title 18, United States Code 1153, 113(a)(3) and 22 23 113(a)(6). TONY CURTIS JUNIOR and RYAN JOHN are both members of the Navajo Indian Tribe and the assault occurred within 24 the exterior boundaries of Indian Country. 25 26 On 07/31/2010, GARRETT FREELAND was interviewed 27 3) and voluntarily provided the following information. GARRETT 28

FREELAND had been drinking an alcoholic beverage the evening of 07/30/2010, near his home on the Navajo Indian Reservation. He was upset and started yelling at his neighbor's house. This was the home of ARLISS JOHN. GARRETT FREELAND could tell that someone was inside the ARLISS JOHN residence. GARRETT FREELAND knew that ARLISS JOHN had undergone back surgery and was yelling words to the effect of, "I'm gonna break your back" and "I'm gonna bury you." GARRETT FREELAND continued to drink and smoke cigarettes until he passed out.

4) On 07/31/2010, ARLISS JOHN was interviewed and voluntarily provided the following information. On the evening of 07/30/2010, ARLISS JOHN was in his home on the Navajo Indian Reservation when he heard his neighbors yelling outside. They were saying that they were going to kill ARLISS JOHN and put him six (6) feet under. ARLISS JOHN has issues with his back which limits his mobility. There has been a dispute between his girlfriend's nephews and the neighbors for some time. These disputes will sometimes escalate into physical confrontations. Because of ARLISS JOHN's physical condition and the fact that he was there with his pregnant girlfriend and four (4) young children, ARLISS JOHN was scared for his safety. ARLISS JOHN's girlfriend called the Navajo Police and ARLISS JOHN contacted a family member asking for them to come over and make sure he and his family are safe.

5) On 07/31/2010, RECHEL WILSON was interviewed and voluntarily provided the following information. On the

evening of 07/31/2010, RECHEL WILSON's boyfriend, RYAN JOHN, was contacted by his uncle, ARLISS JOHN. ARLISS JOHN was at home with his family and the boys next door were threatening him saying things like "I'm gonna break your back" and "we'll put you six (6) feet under." RECHEL WILSON, RYAN JOHN, BRANDON JIMENEZ and CLARAPITA JOHN all drove over to ARLISS JOHN's home to help. When they were down the hill from the home the road was too muddy to go any further. They parked and called ARLISS JOHN. ARLISS JOHN drove down the hill to meet them, picked them up and began driving up the hill. The group saw two boys and ARLISS JOHN said they were the ones threatening him. The group got out of ARLISS JOHN's car to tell the boys to leave ARLISS JOHN alone. As they walked towards the area where the boys were they met a woman, later identified as JUDY YAZZIE, who wanted to know who they were and where her son was. RECHEL WILSON said she did not know where JUDY YAZZIE's son was and they were looking for the boys that had been there to tell them to leave ARLISS JOHN alone.

6) JUDY YAZZIE walked away and the group heard the sounds of people walking around in the dark. RYAN JOHN went towards the sound and found two (2) boys, one (1) of whom claimed his name was "Garrett." The boys threw a rock at RYAN JOHN and ran away. As the group were walking back up the hill to ARLISS JOHN's house the group got separated. ARLISS JOHN ended up with CLARAPITA JOHN. RECHEL WILSON, RYAN JOHN and BRANDON JIMENEZ ended up together and walked up the hill. When they came to a trailer that was not ARLISS JOHN's they

encountered JUDY YAZZIE. JUDY YAZZIE was holding a long silver pipe or pole and was with at least two (2) other men. JUDY YAZZIE wanted to know what RECHEL WILSON did with her son and claimed that RECHEL WILSON was trespassing. JUDY YAZZIE swung the pipe at RECHEL WILSON and struck her on the side of the head. RECHEL WILSON yelled at JUDY YAZZIE and JUDY YAZZIE pushed her. RECHEL WILSON pushed her back and RYAN JOHN jumped between RECHEL WILSON and JUDY YAZZIE and told everyone to stop hitting each other. At that point one (1) of the men that was with the lady came at RYAN JOHN with a small sledge hammer. RYAN JOHN saw the man, later identified as TONY CURTIS JUNIOR, and said words to the effect of "if you come at me with that, that's assault with a deadly weapon." TONY CURTIS JUNIOR then said words to the effect of "I don't care if I go down for murder." TONY CURTIS JUNIOR then swung the sledge hammer and struck RYAN JOHN in the head and it made a loud "pop"." RYAN JOHN fell to the ground, started making a snoring sound and there was blood coming from his head. When TONY CURTIS JUNIOR hit RYAN JOHN with the hammer, one (1) of the other men yelled words to the effect of, "Tony, cut it out!" RECHEL WILSON then grabbed TONY CURTIS JUNIOR and in the process ripped the white tank-top that he was wearing. RECHEL WILSON was on the ground with RYAN JOHN yelling for help. BRANDON JIMENEZ ran over to help and the men there began fighting BRANDON JIMENEZ.

7) On 07/31/2010, RYAN JOHN was interviewed and voluntarily provided the following information. On the

evening of 07/30/2010, RYAN JOHN's family was contacted by RYAN JOHN's brother, ARLISS JOHN. ARLISS JOHN said that he was afraid because some people were outside his home threatening him. RECHEL WILSON, RYAN JOHN, BRANDON JIMENEZ and CLARAPITA JOHN then all drove over to ARLISS JOHN's. ended up parking the car and walking up towards ARLISS JOHN's home when they met a female and several males. RECHEL WILSON began fighting with the female, later identified as JUDY YAZZIE, and RYAN JOHN stepped in between the two (2) to break up the fight. RYAN JOHN had one (1) hand on each female pushing them apart when he saw a man in a grey tank-top wearing prescription glasses coming towards him with a small sledge hammer in his raised hand. RYAN JOHN looked at the man, later identified as TONY CURTIS JUNIOR, and said words to the effect of, "Don't! That's assault with a deadly weapon." TONY CURTIS JUNIOR paused for a moment and then hit RYAN JOHN on the left side of his head with the sledge hammer. RYAN JOHN went to the ground.

8) On July 31, 2010, MARVIN YAZZIE was interviewed and voluntarily provided the following information. After initially claiming that his father, BENSON YAZZIE, punched a big guy, later identified as RYAN JOHN, in the lip last night and that sent RYAN JOHN to the hospital, MARVIN YAZZIE stated that he saw his cousin, TONY CURTIS JUNIOR, hit RYAN JOHN in the head with a small sledge hammer. Last night MARVIN YAZZIE, JUDY YAZZIE, BENSON YAZZIE, JUSTIN FRANK, JEROME FRANK and TONY CURTIS JUNIOR all encountered a female and two (2)

males near a trailer. One (1) male, RYAN JOHN, was bigger than the other. JUDY YAZZIE and the female, later identified as RECHEL WILSON, got into a fight and RYAN JOHN took a swing at BENSON YAZZIE with his fist and missed. BENSON YAZZIE punched RYAN JOHN one (1) time in the face. TONY CURTIS JUNIOR then hit RYAN JOHN in the head with the small sledge hammer and RYAN JOHN fell to the ground. TONY CURTIS JUNIOR then started punching the RYAN JOHN on the side and kidneys with his fists when RYAN JOHN was lying on the ground. MARVIN YAZZIE then took off and did not see what happened next.

9) On 07/31/2010, JUDY YAZZIE was interviewed and voluntarily provided the following information. The night before JUDY YAZZIE had gotten in an argument with her son, GARRETT FREELAND, when he was drunk. GARRETT FREELAND walked out and later JUDY YAZZIE wanted to find him. JUDY YAZZIE heard that there were some people with bats around in the dark and she did not want GARRETT FREELAND getting hurt. JUDY YAZZIE took a pipe she uses for her stove, TONY CURTIS JUNIOR took a small sledge hammer, JEROME FRANK took a pipe, MARVIN YAZZIE took a stick and BENSON YAZZIE had nothing in his They all went looking for GARRETT FREELAND and encountered some of ARLISS JOHN's relatives, a girl, later identified as RECHEL WILSON, and two (2) boys. One (1) of the boys, later identified as RYAN JOHN, was bigger than the other and RECHEL WILSON was holding a stick. JUDY YAZZIE began fighting with the RECHEL WILSON and RYAN JOHN "jumped out." TONY CURTIS JUNIOR then hit RYAN JOHN in the head with the

small sledge hammer and RYAN JOHN fell to the ground. TONY CURTIS JUNIOR then started hitting RYAN JOHN in the face with his fists and RECHEL WILSON was screaming for TONY CURTIS JUNIOR to stop.

On 07/31/2010, JUSTIN FRANK was interviewed in 10) custody on unrelated charges at the Crownpoint Detention Center. JUSTIN FRANK waived his constitutional rights and provided the following information. The evening of 07/30/2010, JUSTIN FRANK, MARVIN YAZZIE, TONY CURTIS, JUDY LYNN, JEROME FRANK and BENSON YAZZIE all went out near JUSTIN FRANK's house looking for some people who had been chasing JUSTIN FRANK. They found a girl, later identified as RECHEL WILSON, and a tall quy, later identified as RYAN JOHN. JUDY LYNN and RECHEL WILSON got into an argument and RYAN JOHN moved towards JUDY LYNN like he was ready to punch her with his fist. TONY CURTIS JUNIOR then hit RYAN JOHN in the head with a sledge hammer that he was holding. RYAN JOHN fell to the ground and TONY CURTIS JUNIOR started "stomping" RYAN JOHN with his fists and feet. JEROME FRANK, MARVIN YAZZIE, JUSTIN FRANK and JUDY LYNN tried to pull TONY CURTIS off of RYAN JOHN but TONY CURTIS JUNIOR kept hitting RYAN JOHN . JUNIOR just "snapped." Finally BENSON YAZZIE told TONY CURTIS to stop and TONY CURTIS JUNIOR got up off of RYAN JOHN and walked away. JUSTIN FRANK thinks that RYAN JOHN was actually trying to break up the fight between RECHEL WILSON and JUDY LYNN and was not going to punch JUDY LYNN with his fist.

On 07/31/2010, TONY CURTIS JUNIOR was interviewed and voluntarily provided the following information. The night before TONY CURTIS JUNIOR was dropped off at his house on the Navajo Indian Reservation. Later that evening TONY CURTIS JUNIOR went out walking around with other family members to look for GARRETT FREELAND. The family believed that there was a group of people walking around with bats and GARRETT FREELAND was not accounted for. TONY CURTIS JUNIOR picked up a twenty (20) ounce sledge hammer and brought it with him for self defense. TONY CURTIS JUNIOR was with JUDY YAZZIE, MARVIN YAZZIE, JUSTIN FRANK, JEROME FRANK and BENSON YAZZIE. Everyone else in that group had a stick or pole with them. That group walked up and met a girl, later identified as RECHEL WILSON, and a quy, later identified as RYAN JOHN. RECHEL WILSON was holding a bat and RYAN JOHN was holding a flashlight and what looked to TONY CURTIS JUNIOR like a broom handle. RECHEL WILSON and JUDY YAZZIE started arguing and RYAN JOHN charged towards JUDY YAZZIE saying "don't touch her." RYAN JOHN placed his hands on JUDY YAZZIE and TONY CURTIS JUNIOR was afraid RYAN JOHN was going to push or throw JUDY YAZZIE. TONY CURTIS JUNIOR moved towards RYAN JOHN while holding the sledge hammer with both hands. CURTIS JUNIOR hit RYAN JOHN in the head with the sledge hammer one (1) time to "put him down" but not intending to kill him. TONY CURTIS JUNIOR then fell to the ground with RYAN JOHN, dropped the hammer and punched RYAN JOHN in the stomach approximately two (2) times. JUDY YAZZIE told TONY CURTIS JUNIOR to stop and she and RECHEL WILSON pulled him off of

RYAN JOHN because RYAN JOHN was knocked out. When they pulled TONY CURTIS JUNIOR off of RYAN JOHN, TONY CURTIS JUNIOR stopped punching RYAN JOHN. Last night TONY CURTIS JUNIOR did not tell the police that he hit RYAN JOHN in the head with a sledge hammer because TONY CURTIS JUNIOR was scared. TONY CURTIS JUNIOR believes that it is possible RYAN JOHN was actually trying to break up the fight between JUDY YAZZIE and RECHEL WILSON.

12) On 07/31/2010, affiant spoke with Charge Nurse Holly Markham at the University of New Mexico Hospital in Albuquerque, New Mexico. RYAN JOHN sustained a fractured skull that required surgery to repair. At that time RYAN JOHN was recuperating from the surgery and was expected to survive.

Based on the above, the affiant believes 13) probable cause exists that TONY CURTIS JUNIOR committed assault with a dangerous weapon against RYAN JOHN resulting in serious bodily injury within the exterior boundaries of Indian Country, New Mexico, in violation of Title 18, United States Code 1153, 113(a)(3) and (a)(6) on or about 07/30/2010. Therefore, the affiant respectfully requests that an arrest warrant for TONY CURTIS JUNIOR be issued. Zốhn A.
