On June 22, 2005 defendant was convicted in the State of New Mexico Third Judicial District Court, County of Dona Ana of failure to register. The defendant was committed to the custody of the New Mexico Corrections Department for a term of eighteen (18) months, followed by one (1) year of parole. On 11/24/2009 defendant signed a New Mexico Corrections Department Notice to Register Form which states he must register with the county sheriff for the county in which you will reside no later than 10 day after release from custody. In addition defendant was also notified through the New Mexico Corrections Department Form if defendant works or attends school in another state defendant must contact the appropriate agency in that state within 10 days for registration requirements. Defendant was notified on the New Mexico Corrections Department Registration Form that if he moves to another state, he is required to follow the registration requirements present in the other state. On 09/05/2010 through witnesses' statements it was learned subject had been living at 1832 E. Cliff Drive, El Paso, TX 79902 since his release from custody on or about November 28, 2009 until on or about March of 2010. Defendant failed to register as a sex offender by failing to notify El Paso County Sheriff's office that he was living in El Paso, TX. In addition the witness' stated that the defendant had moved from El Paso, TX on or about March of 2009 to Albuquerque, NM for employment. The defendant has been working and living in NM since on or about March of 2009. The New Mexico Department of Public Safety -Santa Fe, NM has no record of the defendant registering in NM since his release from custody on or about November 28, 2009.
