9	I, the undersigned, being duly sworn, hereby depose					
10	and state as follows:					
11						
12	1. I am a Special Agent (SA) of the Federal Bureau of					
13	Investigation (FBI) and have been employed in that capacity					
14	since February of 2009. I am currently assigned to the					
15	Albuquerque Division and have primary investigative					
16	responsibilities in major crimes, violent actions, and federal					
17	violations. The information set forth in this affidavit has					
18	been derived from my own investigation or communicated to me by					
19	other sworn law enforcement officers or from other reliable					
20	sources.

22	2. On February 12, 2010, the Laguna Pueblo Police					
23	Department initiated an investigation regarding the alleged					
24	sexual abuse of Jane Doe, year of birth 2000, by her					
25	grandfather, Raymond Martin, year of birth 1948, Social Security					
26	account number XXX-XX-7231. Both Jane Doe and Raymond Martin					
27	are enrolled members of Laguna Pueblo, and the assault occurred					
28	within the exterior boundaries of Laguna Pueblo. The					

investigation was referred to the Albuquerque Division, FBI on February 23, 2010.

3. On March 4, 2010, Jane Doe was interviewed at the All Faiths Receiving Home Children's Safehouse, in Albuquerque, New Mexico. During that interview, Jane Doe disclosed that her grandfather, Ray Martin, touched her on her vagina on multiple occasions. She disclosed that in one instance, Martin came into her bedroom, grabbed her, pulled down her pants, held her and then directly touched her vagina with his hand. She recalled that in another instance her brother observed Martin touching her, and that Martin then stopped. In all, Jane Doe disclosed that Martin had touched her on her vagina in at least four different rooms in her residence, including her bedroom, the kitchen, the hallway and the living room.

4. On April 2, 2010, Raymond Martin, year of birth 1948, social security account number XXX-XX-7231 was located at his residence in Mesita Village, Laguna Pueblo, and interviewed by FBI SA Christopher J. Geiger and FBI SA Anthony J. Costanza. During the interview, Martin confessed to touching Jane Doe on four occasions, though he admitted there may have been more instances. Martin recalled that when Jane Doe was approximately eight years old he entered her bedroom and placed his hand directly on her vagina, under her jeans and underwear. He further described how, at this time, his fingertips slightly penetrated her vagina. Martin recalled that when Jane Doe was approximately nine years old he put his hand under her jeans and

touched her on her vaginal area, over her underwear, in the kitchen of his residence. He further stated that Jane Doe's brother walked into the kitchen during this incident, and observed Martin touching Jane Doe. Martin also admitted to touching Jane Doe on her vaginal area over her jeans, while the two of them were in the hallway of the residence. Finally, Martin recalled that when Jane Doe was approximately ten years old, he entered her bedroom at approximately 4:00 p.m. in the afternoon and touched her buttocks over her pants while she was napping.

Based on the information set forth in this affidavit, your affiant submits that there is probable cause to believe that in the years 2008, 2009, and up and into February 2010, Raymond Martin, a 61 year-old male and enrolled member of Laguna Pueblo, did sexually assault a juvenile female who had not yet reached the age of twelve years and who is an enrolled member of Laguna Pueblo, by penetrating the genital opening with his fingertips, by intentionally touching, not through the clothing, her vaginal area with his hand, and by intentionally touching, through the clothing, her vaginal area and buttocks with his hand; and that said sexual assault occurred in the state and district of New Mexico, within Indian Country, in violation of Title 18, United States code, Sections 1153, 2241(c),
