On or about March 22, 2009 in Eddy county, in the Judicial District of New Mexico, defendant(s) did, *(Track Statutory Language of Defense)* possess firearms in and affecting commerce after being convicted of a crime punishable for more than one year in violation of Title 18 United States Code, Section(s) 922(g)(1)

This complaint is based on the following facts:


I, Greg Carrasco, being duly sworn, state that I am employed as a Detective with the Roswell Police Department and currently commissioned as a Task Force Agent (TFA) with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). I have been so employed with the police department for eleven years and a TFA for over one year. I am currently assigned to work in the Roswell, New Mexico area.

1. On March 20, 2009, an armed robbery occurred at 905 S Cypress Carlsbad NM and a firearm was stolen. Eddie Joe REZA was a suspect. The victim and REZA sustained gun shot wounds during the incident. On March 22, 2009, Carlsbad Police Department (CPD) Detective Jennifer Moyers learned information that REZA was staying at 4905 Concho Road Carlsbad NM 88220 and had a 357 SIG caliber handgun, an "uzi" type handgun, and another unknown type handgun in his possession. On the same date, Detective Moyers obtained a District Court state search warrant for 4905 Concho Road. The CPD SWAT Team was to secure the residence for the execution of the search warrant. The SWAT Team entered the residence and encountered REZA in a bedroom. REZA shot at SWAT members and barricaded himself in the bedroom. REZA surrendered several hours later. No one was injured during the incident. On the same date, New Mexico State Police (NMSP) Agents Christopher Boor, Justin Fedric, Jason Knapp, Monica Martinez-Jones, and Norman Rhoades responded to the scene. Agents were briefed on the incident and interviewed all Officers involved and a witness, Mary Ann Flores. Agent Boor learned from Ms. Flores that REZA was staying with her at 4905 Concho Road. Ms. Flores advised that she saw REZA in possession of the firearms in the residence and saw REZA shooting at the Officers.

2. On March 23, 2009, Agent Fedric obtained and executed a District Court state search warrant on 4905 Concho Road. Agent Rhoades located and collected the following evidence. A Glock, model 31, 357 SIG caliber pistol, SN: ENE848 was located in the west bedroom on the bed. The firearm was loaded with one Winchester 357 SIG cartridge in the chamber and four Winchester 357 SIG cartridges in the magazine. Eight Federal 357 SIG casings and one Winchester 357 SIG casing were located in the same bedroom. An Intratec, model TEC-DC9, 9mm pistol, SN: D047954 was located underneath the bed. The firearm was loaded with one Blazer 9mm cartridge in the chamber and forty one Blazer 9mm cartridges in the magazine. A Blazer 9mm casing was located underneath the bed. A box containing forty one Federal 357 SIG cartridges was located on a couch in the living room. A Beretta, model 950BS, 22 short caliber pistol, SN: BER23029T was located in a plaid bag in the living room. The firearm was loaded with three Remington 22 caliber cartridges in the magazine and none in chamber. A 9mm weapon magazine was located in the same bag. The magazine contained twenty nine Blazer 9mm cartridges.
  
3. On September 28, 2009, TFA Carrasco obtained certified copies of the Judgment and Sentences pertaining to REZA from the Eddy County District Court Clerks Office. Upon review of Judgment and Sentence No. CR-95-185-S, TFA Carrasco observed that on August 7, 1995 REZA was convicted of Failure To Appear. On October 5, 1995 REZA was sentenced to eighteen months in the Department of Corrections. Upon review of Judgment and Sentence No. CR-95-209-JWF, TFA Carrasco observed that on January 3, 1996, REZA was convicted of Receiving Stolen Property and Tampering With Evidence. On February 15, 1996, REZA was sentenced to eighteen months in the Department of Corrections followed by one year parole on each count. Upon review of Judgment and Sentence No. CR-97-96-JWF, TFA Carrasco observed that on April 10, 1997, REZA was convicted of Possession of a Controlled Substance, to-wit: Cocaine. On April 10, 1997, REZA was sentenced to eighteen months in the Department of Corrections followed by one year parole. Upon review of Judgment and Sentence No. CR-98-156-JWF, TFA Carrasco observed that on December 14, 1998, REZA was convicted of Shooting At Or From A Motor Vehicle Or Into An Occupied Dwelling. On December 14, 1998, REZA was sentenced to eighteen months in the Department of Corrections followed by one year parole.

4. On September 28, 2009, TFA Carrasco test fired the weapons pertaining to REZA, that being a Glock, model 31, 357 SIG caliber pistol, SN: ENE848, an INTRATEC, model TEC-DC9, 9mm caliber pistol, SN: D047954, and a Beretta, model 950, 22 caliber pistol, SN: BER23029T. All three firearms were found to function as designed.
5. One of the firearms was manufactured by Glock and had the stampings of "MADE IN AUSTRIA". One of the firearms was manufactured by Intratec and had the stampings of "MIAMI FL.". The other firearm was manufactured by Beretta and had the stampings of "MADE BERTTA USA CORP., ACKK, MD.". TFA Carrasco knows through training and experience that Glock, Intratec, and Beretta firearms are not and have never been manufactured in New Mexico. Therefore the firearms possessed by REZA on March 22, 2009, traveled in and affected interstate commerce.
