INDICTMENT

The Grand Jury charges:

Count 1

On or about January 26, 2007, in Lea County, in the District of New Mexico, the defendant, JACOB FRAGOSO, unlawfully, knowingly and intentionally did distribute a mixture and substance containing a detectable amount of cocaine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(C), and 18 U.S.C. § 2.

Count 2

From on or about March 23, 2007, and continuing to on or about March 24, 2007, in Lea County, in the District of New Mexico and elsewhere, the defendants, JACOB FRAGOSO, IGLACER HERNANDEZ, AND ARTURO NAVARRETE, unlawfully, knowingly and intentionally did combine, conspire, confederate and agree with each other and with other persons whose names are known and unknown to the grand jury to commit the following offense against the United States, to wit: distribution of a mixture and substance

containing a detectable amount of cocaine, contrary to 21 U.S.C. §§ 841(a)(1) and (b)(1)(C).

In violation of 21 U.S.C. § 846.

Count 3

On or about March 24, 2007, in Lea County, in the District of New Mexico, the defendant, JACOB FRAGOSO, IGLACER HERNANDEZ, AND ARTURO

NAVARRETE, unlawfully, knowingly and intentionally did distribute a mixture and substance containing a detectable amount of cocaine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(C), and 18 U.S.C. § 2.

Count 4

On or about April 9, 2007, in Lea County, in the District of New Mexico, the defendant, **ARTURO NAVARRETE**, unlawfully, knowingly and intentionally did distribute a mixture and substance containing a detectable amount of cocaine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(C), and 18 U.S.C. §2.
