AFFIDAVIT SUPORTING COMPLAINT ON HENIO M. HINOJOS

- 1. This child pornography investigation began when, on or about March 17, 2008, a State Trooper and Computer Forensics Specialist (the "Trooper") contacted ICE Special Agents concerning a report the Trooper received from a student at an east coast university. The student reported that she had received an unsolicited "spam" email that contained a link to a web site which she believed contained child pornography. The Trooper, utilizing his training in computer forensics, analyzed the email that the student had received and concluded that the "spam" email received by the student contained a link to a web site that contained child pornography. The Trooper then performed a records check using a publicly available database in an effort to identify the owner of that child pornography website. Through this process it was revealed that the website was registered to a resident of Massachusetts. The Trooper contacted the ICE Boston field office.
- Upon receiving the information from the Trooper, ICE Boston agents, utilizing an undercover computer, accessed the web site. Through further investigation, agents from ICE Boston learned that the web site is a pay-for-access commercial website that offers child pornography in a variety of media formats, including still images and VHS or DVD videos, and website access to the same.
- 3. Agents have also learned that owners of the web site employ a method known as "spamming" to advertise child pornography products by sending unsolicited emails containing links to Uniform Resource Locators (URLs) that advertise CP Company child pornography products (hereinafter referred to as "advertisement websites"). These URLs

or advertisement websites may also be found and accessed using a publicly available search engine, such as Google. The use of advertisement websites is a common practice for websites that offer material that is illegal to view, order, and possess as it allows the "store front" website to operate while masking the identities of the website owners and operators. Such companies often utilize the stolen identities of former customers and other individuals to create and register URLs or domain names for illegal websites and content. These advertisement websites act as a shield for the "store front" company until the persons whose identities were stolen or law enforcement become aware of the illegal website and shut it down.

- 4. On July 08, 2008, HENIO M. HINOJOS using physical, "brick and mortar" Western Union transaction center, sent \$130.00 by Western Union to an individual located in OMSK, Russia, traceable with the Western Union Money Transfer Control Number ("MTCN") 9464091221. At that time, this individual acted as a money courier for CP Company. The unique dollar amount of \$130.00 is the price point for the Child Pornography product offered by this web site at that time. HINOJOS listed the address 604 Alhambra, Elephant Butte, NM, on that money order.
- 5. In March 2010, law enforcement agents in an undercover capacity, sent a letter by U.S. mail to the P.O. Box 1480, Elephant Butte, NM, *i.e.*, the residential address provided by HINOJOS during his Western Union transaction, inviting him to visit a website (undercover) to request child pornography or to request a catalogue offering child pornography through the U.S. mail. The law enforcement agents took this address from a CP Company customer list and, using information provided by the U.S. Postal Service,

associated the address 604 Alhambra, Elephant Butte, NM with the address P.O. Box 1480, Elephant Butte, NM.

- 6. On April 20, 2010, a law enforcement officer on the east coast of the United States received a white business sized envelope. The envelope was handwritten and addressed to the child pornography provider. The return address bearing Gene HINOJOS with a return address of P.O. Box 1480, Elephant Butte, NM, inside the envelope was a portion of the same yellow solicitation mailed to HINOJOS on or about April 8, 2010. This form contained the same handwritten information for address as listed on the return portion of the envelope. There was also a signed endorsement and the author provided an email address of "gnhinojos@yahoo.com." The author of this form requested catalogs for "hidden cam & voyeur", "masturbation ua girls", "pedophilia", "pre-teen girls", and "young teen girl." HINOJOS also certified that he was not a law enforcement officer and not affiliated with law enforcement.
- 7. On or about April 23, 2010, the undercover officer mailed HINOJOS a child pornography catalogue that described the collection of videos available from the distributer, including the age of the participants, the type of sexual activity contained on the videos, the prices, and the order and method of payment procedures. The catalogue included an order form that provided the target an opportunity to purchase child pornography. The correspondence between the undercover agent and HINOJOS was assigned a unique customer number, to wit: 3055030 and HINOJOS was advised to retain this number and use it in all future correspondence.
- 8. HINOJOS then filled out the mail order form, indicating the child pornography product(s) he wanted to purchase and mailed the order form back to the undercover U.S.

mail address in a state located on the eastern coast of the United States with a method of payment, to wit: \$85.00 money order. HINOJOS also certified that he was not a law enforcement officer and not affiliated with law enforcement.

The undercover officer, using a covert screen name [denoted for purposes of this complaint as "UC" (not the real screen name)], then began to communicate directly by email with HINOJOS who used the screen name Gene HINOJOS at email address gnhinojos@yahoo.com..

- Regarding payment, on or about May 13, 2010, an undercover agent received an envelope addressed to the undercover address associated with the distributor in Harrisburg, the same address that was previously supplied by HINOJOS during the U.S. mail correspondence. This envelope was postmarked, May 10, 2010, Albuquerque, New Mexico and contained a return address of P.O. Box 1480, Elephant Butte, NM 87935. Enclosed with the letter postmarked May 10, 2010, was a money order made payable to the child pornography provider.
- 10. The money order is dated May 10, 2010, made payable in the amount of \$85.00. Noted in the upper left corner of this check the following is imprinted, and signed Gene HINOJOS. This amount of the money order was consistent with the total price of the order previously placed by HINOJOS of \$85.00.

The package was delivered to the U.S. Post Office in Elephant Butte, New Mexico. Agents observed HINOJOS pick up the package at approximately 11:00am on May 25, 2010. In a consensual interview HINOJOS stated that he had placed an order for the child pornography that he had just picked up at the Post Office, and sent a money order to pay for the DVD's prior to receiving the package. HINOJOS stated he also downloaded child pornography and has over 100 images on his computer, along with at least three (3) videos. HINOJOS stated that he is the only person that uses that computer.

I swear under penalty of perjury that the foregoing statements are true and correct to the best of my knowledge.
