INDICTMENT

The Grand Jury charges:

Counts 1 & 2

On or about the dates set forth below, in Quay County, in the District of New Mexico, the defendant, **STEPHEN HENSLEY**, did knowingly receive a visual depiction contained in the computer files described below, which visual depiction had been mailed and shipped and transported in or affecting interstate and foreign commerce, and which contained materials which had been so mailed and shipped and transported in interstate and foreign commerce by any means, including by computer, the production of which visual depiction involved the use of a minor engaging in sexually explicit conduct and is of such conduct:

In violation of 18 U.S.C. §§ 2252(a)(2), 2252(b)(1), and 2256.

Count 3

On or about July 1, 2010, in Quay County, in the District of New Mexico, the defendant, **STEPHEN HENSLEY**, did knowingly possess a custom built computer, containing an Western Digital 80 Gigabyte Hard Drive, model WD800JB-00CRA1, serial number WCA8E5267882, containing visual depictions that had been shipped and transported in or affecting interstate and foreign commerce and which were produced using materials which had been shipped and transported in interstate and foreign commerce, by any means, including by computer, the production of which visual depictions involved the use of a minor engaging in sexually explicit conduct and is of such conduct.

In violation of 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256.

Count 4

On or about July 1, 2010, in Quay County, in the District of New Mexico, the defendant, **STEPHEN HENSLEY** did knowingly possess a Hewlett Packard

Slimeline, Pavilion Computer, serial number CNX83924NO, containing a Hitachi 500 Gigabyte Hard Drive, serial number GEA534RF14Y3WA, containing visual depictions that had been shipped and transported in or affecting interstate and foreign commerce and which were produced using materials which had been shipped and transported in interstate and foreign commerce, by any means, including by computer, the production of which visual depictions involved the use of a minor engaging in sexually explicit conduct and is of such conduct.

In violation of 18 U.S.C. §§ 2252(a)(4)(B), 2252(b)(2), and 2256.

FORFEITURE ALLEGATIONS


Upon conviction of any offense alleged in this Indictment, Defendant **STEPHEN HENSLEY** shall forfeit to the United States pursuant to 18 U.S.C. §§ 2252 and 2253:


- A). A custom built computer, containing an Western Digital 80 Gigabyte Hard Drive, Model WD800JB-00CRA1, Serial Number WCA8E5267882 (**Evidence # QAQ2**),
- B). Hewlett Packard Slimline, Pavilion Computer, serial number CNX83924NO, containing a Hitachi 500 Gigabyte Hard Drive, serial number GEA534RF14Y3WA (**Evidence # QAQ6**),
- C). One CD-R (**Evidence # QAQ3**).
