I HAVE BEEN A SPECIAL AGENT 12 (SA) FOR APPROXIMATELY 2 YEARS, AND CURRENTLY AM ASSIGNED TO THE 13 ALBUOUEROUE DIVISION OF THE FBI AND PRIMARILY INVESTIGATE VIOLENT CRIMES ON THE NAVAJO INDIAN RESERVATION. THE FOLLOWING FACTS WERE 14 DETERMINED DURING THE COURSE OF AN INVESTIGATION CONDUCTED BY 15 AGENTS OF THE FBI AND NAVAJO POLICE DEPARTMENT CRIMINAL 16 INVESTIGATORS AND COMMUNICATED TO ME. 17 2) AT APPROXIMATELY 12:30 ON 01/11/2011 SHIPROCK 18 CRIMINAL INVESTIGATOR DALE WEST CONTACTED SA DUSTIN GRANT REGARDING 19 A MURDER CASE. THE FACTS OF THE INVESTIGATION ARE AS FOLLOWS: 20 3) AT APPROXIMATELY 11:45 AM ON 01/11/2011, THE SHIPROCK 21 POLICE DEPARTMENT DISPATCH WAS CONTACTED BY A MALE CALLER, WHO 22 ADVISED THAT SOMEONE HAD BEEN STABBED AT MESA FARM ROAD LANE 5 WEST, SHIPROCK, NEW MEXICO. OFFICERS ARRIVED ON SCENE AND MET WITH 23 PERRY HAYES SR. (PERRY SR.), WHO DIRECTED OFFICERS INTO THE LIVING 24 ROOM WHERE A NATIVE AMERICAN FEMALE, IDENTIFIED AS LENA HAYES, WAS 25 FOUND DEAD WITH A STAB WOUND TO THE NECK. LENA IS THE WIFE OF PERRY 26 HAYES SR. ALSO FOUND IN THE RESIDENCE WAS A LARGE KITCHEN SIZED KNIFE, WITH APPARENT BLOOD ON THE BLADE. 27 28

SON, PERRY HAYES JR (PERRY JR.) AND PAMELA NAVASIE. PAMELA IS THE GIRLFRIEND OF PERRY JR. LENA WAS DESCRIBED AS AN ELDERLY WOMAN REQUIRING A WALKER AND ASSISTANCE FROM FAMILY MEMBERS.

- 5) PERRY SR. STATED THAT AN ARGUMENT HAD BROKEN OUT BETWEEN PAMELA AND PERRY JR. IN THE MORNING OF 01/11/2011. PERRY SR. TOOK PERRY JR. OUT OF THE HOUSE SO HE COULD CALM DOWN. THEY DROVE AWAY FROM THE RESIDENCE LEAVING LENA AND PAMELA TOGETHER BY THEMSELVES. AT APPROXIMATELY 11:45 AM PERRY CAME BACK TO THE RESIDENCE AND FOUND LENA DEAD IN THE LIVING ROOM WITH BLOOD ON THE FLOOR AND HE CALLED 911.
- 6) PAMELA WAS CONTACTED BY SHIPROCK POLICE DEPARTMENT AT HER SISTER'S HOUSE IN HOGBACK, NEW MEXICO, AND WAS BROUGHT IN FOR QUESTIONING. SHE GAVE A SPONTANEOUS STATEMENT TO THE POLICE OFFICER THAT IT WAS SELF DEFENSE AND THAT SHE "SHOULD KNOW BETTER THAN TO MESS WITH A HOPI". PAMELA WAS INTERVIEWED BY SA GRANT AND CI WEST WHERE THE INTERVIEW ROOM WAS EQUIPPED TO RECORD IMAGES AND SOUND. SHE WAS ADVISED OF HER RIGHTS AND AGREED TO ANSWER QUESTIONS. PAMELA STATED THAT SHE HAD STABBED LENA IN THE NECK WITH A KNIFE BECAUSE THAT WAS THE ONLY WAY TO MAKE HER STOP TALKING. SHE HAD GRABBED THE KNIFE FROM THE KITCHEN BECAUSE LENA HAD BEEN CALLING HER NAMES AND ARGUING WITH PAMELA AFTER PERRY JR. AND PERRY SR. LEFT THE HOUSE.
- 7) SA GRANT AND CI WEST ALSO IDENTIFIED APPARENT BLOOD STAINS ON PAMELA'S CLOTHING AND HANDS.
- 8) A CHECK OF NAVAJO NATION ENROLLMENT RECORDS, SHOW LENA IS AN ENROLLED MEMBER OF THE NAVAJO INDIAN TRIBE. PAMELA CLAIMS SHE IS HALF NAVAJO AND HALF HOPI. INVESTIGATORS ARE WAITING FOR ENROLLMENT VERIFICATION. THE LOCATION OF THE MURDER IS LOCATED WITHIN THE EXTERIOR BOUNDARIES OF THE NAVAJO INDIAN RESERVATION.
 - 9) BASED ON THE ABOVE, YOUR AFFIANT SUBMITS,

1	PROBABLE CAUSE EXISTS TO BELIEVE PAMELA NAVASIE, AN INDIAN
2	PERSON, COMMITTED THE FOLLOWING OFFENSES: MURDER, THE
3	UNLAWFUL KILLING OF A HUMAN BEING WITH MALICE AFORETHOUGHT,
	THAT IS SHE MURDERED, LENA HAYES, AN INDIAN PERSON, BY
4	STABBING HER WITH A KNIFE, IN VIOLATION OF TITLE 18, UNITED STATES CODE 1111; AND THAT THE OFFENSE OCCURRED IN INDIAN
5	COUNTRY, TO WIT THE NAVAJO INDIAN RESERVATION, IN VIOLATION
6	OF TITLE 18, UNITED STATES CODE 1153.
