

**UNITED STATES v. NICHOLAS COSMO**  
**- CRIMINAL DOCKET #CR-09-0255, USAO #2008R01592**

Before the Honorable Denis R. Hurley, United States District Judge, Eastern District of New York, 930 Federal Plaza, Central Islip, New York.

Nicholas Cosmo, the owner and president of Agape World, Inc. and Agape Merchant Advance, LLC, was arrested on January 26, 2009 pursuant to a federal complaint charging him with mail fraud. On April 29, 2009, defendant Nicholas Cosmo was arraigned before the Hon. Magistrate Thomas Boyle and pleaded not guilty to a 32 count indictment charging mail fraud and wire fraud. After a detention hearing, Judge Boyle granted bail in the amount of \$750,000 secured by real property and money. The conditions of bail were home confinement with an electronic bracelet with 24 hour monitoring by pre-trial services. He is subject to random visits by probation and will only be able to leave the home for emergency medical issues. Any other requests to leave the home for any other purpose must be made in writing to the Court and requires prior approval of the Court. He is also not allowed internet access or allowed to transfer any assets. The government appealed this ruling regarding the amount of bail and on May 19, 2009 a bail hearing was held before Judge Hurley. On that date, Judge Hurley increased the bond to \$1.25 million to be secured by three homes and several bank accounts of family members and friends. If the defendant meets the bail package requirements, he will be released on bond and will be subject to home confinement with an electronic bracelet with 24 hour monitoring. Special conditions were set which included random visits to the home by pre-trial services, no internet access, no outside employment, conduct no business within the home that requires and fiduciary responsibilities and the defendant will only be permitted to leave the home for medical emergencies. All other requests to leave the place of home detention must be pre-approved by pre-trial services. Defendant will meet with his attorney at the place of home detention or at the federal courthouse. If the defendant leaves the house for court dates, he must be accompanied security personnel. As of May 22, 2009 the defendant was still incarcerated at the Nassau County Correctional Center. On July 23, 2009, the defendant was released on a \$1,250,000.00 secured appearance bond and is subject to home detention with electronic monitoring with the following conditions: No computer or internet access, 24-hour telephone monitoring by security company, unable to use cell phone or any other phone in residence, can only leave the place of home detention for court appearances and must be accompanied by a security guard from a security firm paid for by his family. Not allowed to perform any type of business from the home or to engage in any activity with a fiduciary responsibility. On September 25, 2009, the government made a bail application to have the defendant's bail revoked due to what it believes are violations of the bail conditions. On October 9, 2009, after a three-day bail revocation hearing, Judge Hurley ordered defendant Nicholas Cosmo to return to jail. The next court date is a status conference, scheduled for January 15, 2010 at 10:00 a.m. before Judge Hurley.

The office has also greatly assisted the trustee in locating other assets of Agape World, Agape Merchant Advance and its subsidiary companies to ensure compensation to all victims.
