# **INDICTMENT**

### **COUNT ONE**

### THE GRAND JURY CHARGES THAT:

At all times material to this indictment:

- 1. The Philadelphia Housing Authority ("PHA") was a public, not-for-profit, state agency whose central mission was to provide low-income Philadelphians with decent, affordable housing. PHA owned, built, maintained and rented housing for low-income Philadelphians.
- 2. Much of PHA's funding came directly and indirectly from the federal government and PHA received annual benefits in excess of \$10,000 in each of calendar years 2007 and 2008 under federal programs involving grants, contracts, subsidies, loans, guarantees and other forms of federal assistance.
- 3. PHA's housing stock ("sites") included low-rise garden complexes, clusters of attached town-house properties and what were called "scattered site" properties, that is, apartments and homes in individual, stand-alone houses located throughout Philadelphia. Sometimes this housing was also referred to as "Section 8" housing. These were federally subsidized rentals in private housing which Philadelphians may qualify to rent under the income restrictions of Section 8 of the Housing Choice Program.

4. Co-Conspirator Richard Perri, known to the grand jury and charged elsewhere, was a materials coordinator for the PHA Maintenance Department from in or about November 1998 until in or about July 2008 and, in that role, was responsible for overseeing purchases of materials for PHA property site maintenance projects. Perri was authorized to order materials for PHA property sites and to charge the purchases to any PHA property site.

## The Conspiracy

From in or about September 2002 through in or about July 2011, in the
 Eastern District of Pennsylvania and elsewhere, defendant

#### **RICHARD LEWIS**

knowingly and willfully conspired and agreed with Richard Perri, and with Jaquel Crews and Mark Miller, known to the grand jury and charged elsewhere, and others, known and unknown to the grand jury, to commit an offense against the United States, that is, to embezzle, steal, obtain by fraud, or otherwise without authority knowingly convert to the use of any person other than the rightful owner or intentionally misapply, property that is owned by, or under the care, custody or control of a state government agency for which co-conspirator Perri was an agent, that is, at least approximately \$348,900 from PHA, in violation of Title 18, United States Code, Section 666(a)(1)(A), and to conceal that theft.

#### MANNER AND MEANS

It was a part of the conspiracy that:

- 6. From in or about September 2002 to in or about July 2011, defendant RICHARD LEWIS conspired with Richard Perri, Jaquel Crews, Mark Miller and others known and unknown to the grand jury to fraudulently sell at a discount building materials that had been purchased with PHA funds and to conceal those fraudulent sales.
- Crews, Mark Miller and others ordered building materials from defendant RICHARD LEWIS, who was employed by PHA. Defendant LEWIS then directed Perri, using his role as PHA materials coordinator, to fraudulently purchase materials from Sawbell Lumber and Home Depot, totaling approximately \$348,910, for use by Crews, Miller and others. Perri disguised those fraudulent purchases as legitimate purchases for PHA, submitted those purchases to the PHA Accounts Payable Department for payment, and arranged for the fraudulently purchased materials to be delivered to private properties specified by defendant LEWIS, Crews, Miller and other purchasers of the Sawbell and PHA materials. Crews, Miller and the other purchasers paid defendant LEWIS and Perri for those fraudulently purchased materials in the amount of approximately thirty to fifty percent of the value of the materials, and defendant LEWIS and Perri split those purchase payments between themselves.
- 8. From on or about July 15, 2008 through on or about July 15, 2011, defendant LEWIS, Crews, Miller and others known to the grand jury made attempts to conceal the fraudulent purchases of PHA building materials by making false statements about the purchase of those materials to members of the PHA Police Department and other law enforcement officers.

#### **OVERT ACTS**

9. In furtherance of the conspiracy, in the Eastern District of Pennsylvania, defendant RICHARD LEWIS and co-conspirator Richard Perri arranged for the purchase of building materials from Sawbell Lumber and Home Depot by PHA for building materials that were then sold to Crews, Miller and others, delivered to specified non-PHA locations, and used by Crews, Miller and the other purchasers of the PHA materials. PHA paid Sawbell Lumber and Home Depot for the following fraudulent purchases of materials requested by Crews, Miller and others, who then paid defendant LEWIS and Perri approximately thirty to fifty percent of the value of the building materials received (each set of purchase transactions constituting a separate overt act):

- 10. On or about July 15, 2008, to conceal his fraudulent purchases of PHA building materials, co-conspirator Jaquel Crews provided false information about his purchases of those building materials to members of the PHA Police Department.
- 11. On or about August 25, 2008, to conceal his fraudulent purchases of PHA building materials, co-conspirator Mark Miller provided false information about his purchases of those building materials to members of the PHA Police Department.
- 11. On or about July 15, 2011, to conceal his fraudulent sale of PHA building materials, defendant RICHARD LEWIS provided false information about his sales of those building materials to members of law enforcement.

All in violation of Title 18, United State Code, Section 371.
