INDICTMENT

The Grand Jury Charges:

COUNT ONE

On or about December 24, 2010, at or near Beaver, Raleigh County, West Virginia, and within the Southern District of West Virginia, defendant STEVEN RUSSELL HELTON did knowingly receive child pornography, as defined in 18 U.S.C. § 2256(8)(A), that had been shipped and transported in and affecting interstate and foreign commerce by any means, including by computer, using a means and facility of interstate and foreign commerce.

In violation of Title 18, United States Code, Sections 2252A(a)(2) and 2252A(b)(1).

COUNT TWO

On or about December 29, 2010, at or near Beaver, Raleigh County, West Virginia, within the Southern District of West Virginia, defendant STEVEN RUSSELL HELTON did knowingly possess material, that is, computer graphic files, containing hundreds of images and videos of child pornography, as defined in 18 U.S.C. § 2256(8)(A), that had been shipped and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

FORFEITURE

In accordance with Section 2253(a) of Title 18 of the United States Code, and Rule 32.2(a) of the Federal Rules of Criminal Procedure, and premised on the conviction of defendant STEVEN RUSSELL HELTON of a violation of 18 U.S.C. §§ 2251 et seq., as set forth in this indictment, the defendant shall forfeit to the United States any visual depictions and any books, magazines, periodicals, films, videotapes, and other matter which contains such visual depictions, which were produced, transported, mailed, shipped, or received in connection with the violations set forth in this indictment, any real and personal property constituting or traceable to gross profits or other proceeds obtained from the violations set forth in this indictment, and any real and personal property used or intended to be used to commit or to promote the commission of the violations set forth in this indictment, including, but not limited to, one Seagate, 500 Gigabyte hard drive, Model Barracuda 7200.11, serial number 9QMB31RE.
