If you do not participate in the meeting **and** do not affirmatively indicate your willingness to serve by returning a completed Questionnaire, you will not be considered. Return of the Questionnaire, however, does not guarantee appointment to the Committee, only that you will be considered.

If you send an individual to represent you at the meeting, that representative must present your written proxy authorizing him or her to act on your behalf.

We have included with this Notice and Questionnaire an Official Committee of Unsecured Creditors Information Sheet which explains in detail the responsibilities, powers and duties of a Committee member. We encourage you to carefully review the Information Sheet as you consider whether to request to be appointed to the Committee. The Committee performs a vital role in chapter 11 reorganizations, and we hope that you will consider sitting on the Committee.
