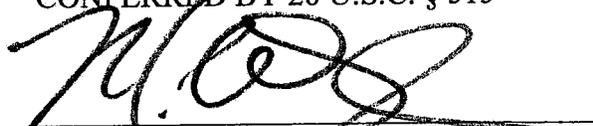
MOTION TO SEAL INDICTMENT

**COUNT ONE**
