

INDICTMENT

The Grand Jury charges:

COUNT ONE: (18 U.S.C. § 2241(c) – Attempted Aggravated Sexual Abuse of a Child) -

On or about December 9, 2012, in the Northern District of California, the defendant,
KEITH LARSON,

(aka, "J_Smith," aka "joelsmith42m") did knowingly and intentionally cross state lines, specifically from Colorado to California, with the intent to engage in a sexual act (as defined in Title 18, United States Code, Section 2246) with a female child who had not attained the age of 12 years.

All in violation of Title 18, United States Code, Sections 2241(c) and 2246.

INDICTMENT

1 COUNT TWO: (18 U.S.C. § 2423(b) – Travel with Intent to Engage in Sexual Conduct with a
2 Minor)

3 On or about December 9, 2012, in the Northern District of California, the defendant,
4 KEITH LARSON,
5 (aka, "J_Smith," aka "joelsmith42m") did knowingly and intentionally travel in interstate commerce,
6 that is from Colorado to California, for the purpose of engaging in a sexual act (as defined in Title
7 18, United States Code, Section 2246), with a person under eighteen years of age.

8 All in violation of Title 18, United States Code, Sections 2423(b) and (e).


