The Grand Jury charges that:

COUNT 1 - RECEIPT OF CHILD PORNOGRAPHY

Beginning at a time unknown and continuing until on or about May 4, 2010, within the Eastern District of Louisiana, and elsewhere, the defendant, **DAN W. JOACHIM, M.D.**, did knowingly receive, and attempt to receive, visual depictions, that is, digital images and computer images, that had been mailed, shipped, and transported in interstate and foreign commerce, by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct as defined in Title 18, United States Code, Section 2256(2), and such visual depictions were of such conduct.

All in violation of Title 18, United States Code, Section 2252(a)(2).

COUNT 2 - POSSESSION OF CHILD PORNOGRAPHY

Beginning at a time unknown and continuing until on or about May 4, 2010, within the Eastern District of Louisiana, and elsewhere, the defendant, **DAN W. JOACHIM, M.D.**, did knowingly possess one or more matters, that is, computer hard drives and computer media, containing digital images, computer images, and digital video files, that contained visual depictions that had been mailed, shipped, and transported in interstate and foreign commerce, and that were produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce, by any means including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct, as defined in Title 18, United States Code, Section 2256(2), and such visual depictions were of such conduct.

All in violation of Title 18, United States Code, Section 2252(a)(4)(B).

NOTICE OF FORFEITURE


1. The allegations of this Bill of Information are re-alleged as if fully set forth herein, for the purpose of alleging forfeiture, pursuant to Title 18, United States Code, Section 2253.


2. If convicted of the offense or offenses set forth above, the defendant, **DAN W. JOACHIM, M.D.**, shall forfeit to the United States any and all materials and property used and intended to be used in the receipt and possession of visual depictions of minors engaging in sexually explicit conduct, as well as any and all property, either real or personal, constituting or traceable to gross profits or other proceeds obtained from the offense. Such property includes, but is not limited to, the following specific items found by federal agents on May 4, 2010:






