The Grand Jury charges that:

#### COUNT 1

### A. <u>AT ALL MATERIAL TIMES HEREIN:</u>

- 1. The defendant, **DAVID PATRICK MCGUIRE**, was previously employed by Shell Exploration & Production Company (Shell) located at 701 Poydras Street, New Orleans, Louisiana until he retired on or about July of 2009.
- 2. Beginning in February of 2010, the defendant, **DAVID PATRICK MCGUIRE**, began making telephone calls to his former Shell supervisor, A.T., and leaving recorded messages on A.T.'s

work voice mail. A.T. was employed at the Shell New Orleans location.

3. The phone messages left by the defendant, **DAVID PATRICK MCGUIRE**, which occurred in the months of February, March, April and May of 2010, consisted of vulgar and derogatory comments directed to A.T.

#### B. THE THREAT:

On or about May 3, 2010, in the Eastern District of Louisiana, the defendant, **DAVID PATRICK MCGUIRE**, through the use of a telephone, an instrument of interstate commerce, did willfully make a threat to kill, injure and intimidate A.T., by means of fire, all in violation of Title 18, United States Code, Section 844(e).

#### COUNT 2

A. The allegations contained in Paragraph A of Count 1 are realleged and incorporated herein in their entirety.

#### B. THE THREAT:

On or about May 3, 2010, in the Eastern District of Louisiana, the defendant, **DAVID PATRICK MCGUIRE**, through the use of a telephone, an instrument of interstate commerce, did willfully make a threat to unlawfully damage and destroy a building, to wit, the residence of A.T. located in Metairie, Louisiana, by means of fire, all in violation of Title 18, United States Code, Section 844(e).

#### **COUNT 3**

A. The allegations contained in Paragraph A of Count 1 are realleged and incorporated herein in their entirety.

## B. <u>THE THREAT:</u>

On or about May 3, 2010, in the Eastern District of Louisiana, the defendant, **DAVID PATRICK MCGUIRE**, through the use of a telephone, an instrument of interstate commerce, did willfully make a threat to unlawfully damage and destroy a building, to wit, the offices of Shell Exploration & Production Company located at 701 Poydras Street, New Orleans, Louisiana, by means of fire, all in violation of Title 18, United States Code, Section 844(e).
